### **Budget Briefing – Baltimore City Public Schools (BCPS)**

### **Purpose:**

For the purpose of calling on regular budget oversight hearings for Baltimore City Public Schools to improve transparency and accountability in the allocation of over a billion dollars in public funding for the vital task of educating Baltimore's children.

### **Agencies/Organizations Reporting**

Bureau of Budget & Management ResearchRobert (Bob) Cenname

### **Current Law**

Baltimore City Code - Article 1, Subtitle 1-City Council, Sections 1-5 and 1-6

§ 1-5. Agencies to provide budget status reports.

### (a) Reports required.

On or before November 1, February 1, May 1, and August 1 each year, the City agencies <u>so requested</u> shall file quarterly budget status reports with the Budget and Appropriations Committee of the City Council. (b) *Contents*.

Each report shall contain the information required by the Committee and be in the format requested.

### (c) Public hearing.

The Committee may hold a public hearing for those agencies not reporting or those showing a projected deficit for the fiscal year.

(d) "City agency" defined

The words "City agencies" include the City trustees and all City sponsored and financed nonprofit corporations. (City Code, 1976/83, art. 1, §5.) (Ord. 72-211; Ord. 77-333; Ord. 81-568; Ord. 82-753.)

### § 1-6. Agencies to provide legislative information.

It shall be the duty of the head of every City department or bureau established by the Baltimore City Charter or by ordinance to provide all technical materials, plats, drawings, and information that are requested by any member or the President of the City Council for the purpose of introducing legislation into the Council. *(City Code, 1976/83, art. 1, §6.) (Ord. 76-080.)*

  - ii. Projection
    - 1. Does this projection include federal funds? Answer: No, the projection is for general funds only
  - iii. School Maintenance
    - 1. Have you looked at how much each school needs for maintenance and/or for upkeep?
    - 2. School maintenance and upkeep is of concern
    - 3. <u>Requested by Member Stokes</u>: Provide a list of each school's maintenance budget. Answer: Will connect you with our Chief Financial Officer
- 2. <u>On February 8, 2022, representative(s)</u> from BCPS will come before the committee to discuss their second quarter projection for this fiscal year; October 1, 2021 through December <u>31, 2021</u>. The fiscal year ends on June 30, 2022.
- 3. Also attached is the Capital Improvement Program for BCPS for 2023 through 2028.

### ACTION REQUESTED OF B/E:

The Board is requested to **NOTE** the report of the Planning Commission on the Baltimore City Public School System's (BCPSS) Capital Improvement Program (CIP) for FY 2023-2028.

### AMOUNT OF MONEY AND SOURCE:

\$750,313,000.00 - FY 2023-2028 in State funding \$114,000,000.00 - Local General Obligation (GO) bonds for FY 2023-2028 \$ 53,898.00 - FY 2023 State funding \$ 19,000,000.00 - Local GO bond for FY23

#### BACKGROUND/EXPLANATION:

Annually the BCPSS must submit an updated and detailed CIP for the upcoming fiscal year and the following five years to the State of Maryland. This CIP submission receives approval from the Board of School Commissioners, the City of Baltimore Planning Commission, Board of Finance, and the Board of Estimates.

On October 7, 2021, the Planning Commission approved the BCPSS CIP for FY 2023-2028.

The requested funding will complete the much larger 21<sup>st</sup> Century Schools initiative by providing funding for critical systemic improvements, such as fire alarms, HVAC systems, and other urgent needs in schools that are not currently funded through 21<sup>st</sup> Century Schools. It will also allow for the renovation and replacement of additional schools to take place. The Board of Estimates' support of this plan will assist the BCPSS' effort to provide enhanced learning environments and improve educational opportunities for the children of Baltimore City.

Board of Finance – Baltimore City Public School System Capital Improvement Program FY 2023 – 2028

#### ACTION REQUESTED OF B/E:

The Board is requested to approve the Baltimore City Public School System (BCPSS) Fiscal Year 2023 – 2028 Capital Improvement Program.

#### BACKGROUND/EXPLANATION:

Procedures for administration of the school capital program require that the BCPSS submit annually an updated detailed capital program for the upcoming year and ensuing five fiscal years to the State Interagency Committee on School Construction. As a condition of receiving State school construction aid, the BCPSS is required to submit the CIP by the end of November of each year.

This action requires the approval of this program by the appropriate local governing body. As a condition of gaining approval of this local government, a review process has been established that includes the School Board, Planning Commission, Board of Finance, and the Board of Estimates, to serve as the means by which the Mayor will support and endorse the program.

The Board of Finance, at a scheduled meeting on October 25, 2021, considered and endorsed the FY 2023 Capital Budget totaling \$72,898,000.00 and the FY 2023-2028 CIP totaling \$864.313,000.00. The annual program distribution are as follows:
