#### **Key Points**

- Period of performance covers January 1, 2022 March 30, 2022.
- The U.S. Department of Treasury does not factor in "commitments," only obligations and expenditures.
- Data are reported to Treasury by expenditure category and at specific time intervals (i.e., quarterly), therefore data do not align with information included in Council Reports or the public-facing dashboard.
- Many agencies are still fully designing and implementing programs, therefore performance data are limited. Additional data on required performance measures will be included in Treasury reports as programs are further implemented and data are available. Performance data included in Council reports are not Treasury required measures.



#### Treasury Report Requirements | Changes Since Last Report

- Expenditure categories: The expenditure categories of some projects changed when Treasury released the Final Rule. All projects have been categorized under the appropriate new expenditure category.
- **Demographic data:** Treasury now requires demographic data for certain projects, specifically if the project serves an impacted or disproportionately impacted community.
- Evidence-based interventions: Treasury now requires data for certain projects on how much funding has been allocated for evidence-based interventions.



#### New and Revised Data | Changes Since Last Report

- New projects: The City added three additional projects: Vaccine Incentives, Food Insecurity, and Lexington Market
- Separation of existing project: Due to the change in expenditure categories, the previous project for Baltimore Development Corporation was separated into two projects: one for grant funding to small businesses and one for technical assistance. Obligations and expenditures were split accordingly between the two projects.
- New expenditures: Six projects have expenditures in this reporting period that did not have expenditures in the previous Treasury report covering the date award through December 31, 2021.
  - Visit Baltimore Recovery Assistance;
  - Baltimore City Workforce Development;
  - Reducing Baltimore Violence Improving Community Violence Interventions;
  - Baltimore Office of Promotion and the Arts Recovery Assistance,
  - COVID19 Health Response Staffing and payroll costs; and
  - Broadband and Digital Equity Phase I.

#### **Vaccine Incentive: \$10.4 million**

• \$1,000 payments to City employees who received their COVID-19 vaccination

#### **Food Insecurity: \$11 million**



- COVID-19 Produce Distribution Response;
- Online SNAP fruit and vegetable incentives;
- Expansion of nutrition incentives at farmers markets;
- Med Star's Good Food Rx program; and
- the Farm Aliance's Black Butterfly Urban Farmer Academy program.



#### **Lexington Market: \$4.9 million**

• Funds will support stall build out for new and legacy vendors at the newly constructed Lexington Market

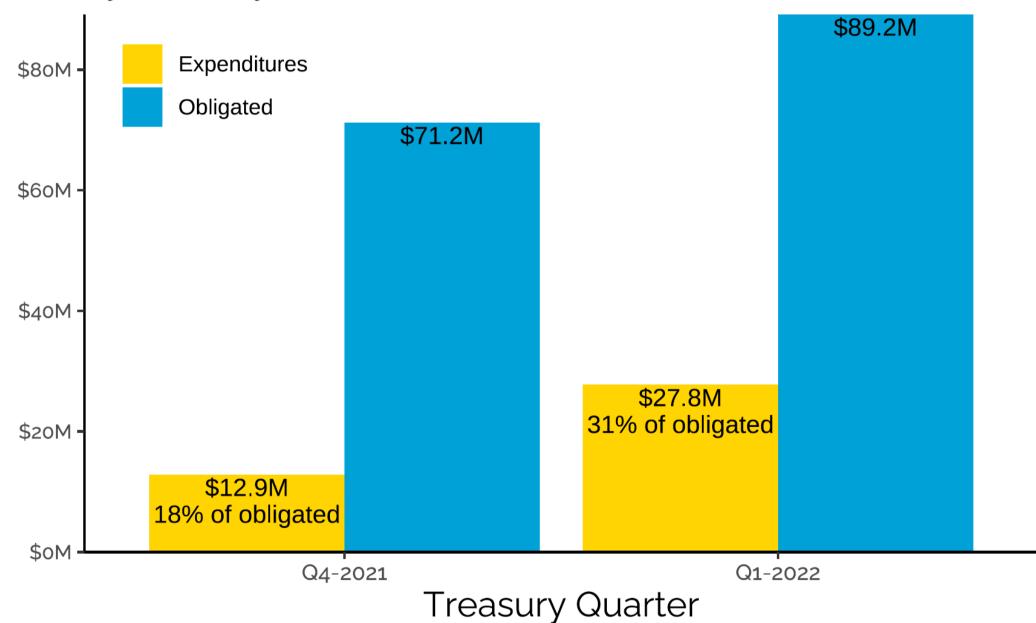

#### Obligations and Expenditures

- For the period of performance, the City of Baltimore reported \$89,188,506 in obligations and \$14,860,786.31 in expenditures for 23 projects across 19 expenditure categories.
- Through March 2022, total expenditures increased to \$27,726,228 (31% of obligations)
- From the January 2022 Treasury report, obligations increased by 25% and reported expenditures increased by 115%.
