Analysis

Current Law

Article V – Comptroller; Section 5(b); Baltimore City Charter; (1996 Edition)

Background

If enacted, Bill 22-0240 would authorize the sale of the property located at 711 North Arlington Avenue (Block 0104; Lot 062) in the <u>Harlem Park neighborhood of the City; Council District #9</u>. *See attached pictures.*

<u>Per the Real Estate</u>, the property is used as an outdoor and gardening space abutted to the NM Carroll Manor Nursing and Rehabilitation Center. A detailed writing of the history of this property is outlined in the agency report. *See attached Real Estate's agency report.*

Upon approval by the Mayor and City Council, <u>the Board of Estimates</u> would have to approve the deal to finalize the disposition.





President and City Council Members:

The Law Department has reviewed City Council Bill 22-0240 for form and legal sufficiency. The bill would allow the Mayor and City Council of Baltimore to sell its interest in the property located at 711 North Arlington Avenue (Block 0104, Portion of Lot 062) and declaring it no longer needed for public use. The bill also provides for a special effective date.

Article V, Section 5(b) of the Baltimore City Charter grants the Department of Real Estate in the Comptroller's Office the power to arrange for the disposition of any building or parcel of land no longer needed by the City for public use, if that sale is approved by the Board of Estimates. Assuming the agency reports reveal that the property is no longer needed for public use, this is the appropriate ordinance to authorize disposition of the subject property. Therefore, the Law Department approves the bill for form and legal sufficiency.

The Department of Real Estate is reporting on CCB 22-0240 Sale of Property – 711 North Arlington Avenue (Block 0104, Portion of Lot 062). The purpose of the bill is to authorize the Mayor and City Council of Baltimore to sell, at either public or private sale, all its interest in certain property located at 711 North Arlington Avenue, which is no longer needed for public use; and provide for a special effective date. If CCB 22-0240 is approved by the City Council, the Board of Estimates will be asked to approve the deal to finalize the disposition.

Background

This property is a 1.22 acre "inner block park" in Harlem Park, one of 29 inner block parks in Harlem Park. The Harlem Park Urban Renewal Plan speaks to the deterioration of these inner block parks and encourages alternative uses. This is consistent with the Harlem Park URP.

N.M. Carroll Manor Nursing Home, an assisted living facility, is located at 701 N. Arlington, which abuts the parcel. They have maintained the parcel for about a decade and has used it as outdoor and gardening space for its residents. With the support of Baltimore City Recreation and Parks, Carroll Manor wants to purchase about 10,000 square feet of the parcel.

In 2019, BCRP Recreation and Parks declared part of the parcel as surplus space. In 2020, the Real Estate office entered into an Exclusive Negotiating Privilege (ENP) and Right-of-Entry agreement to give the nursing home access to the site for some preliminary environmental investigations.

Fiscal Impact

The property has been appraised and, subject to City Council and BOE approval, will sell for \$2,200.

The Department of Real Estate supports the passage of CCB 22-0240.
