Major Issues Discussed

May 26, 2022 - Budget Overview - BBMR

- 1. The budget season started off with a <u>budget overview</u> from the Bureau of Budget and Management Research, BBMR. A PowerPoint presentation was given by agency representative. A copy is on file. Some highlighted topics and/or concerns were:
 - Is concerned about higher gas prices the overall impact of same
 - Cameras
 - Purchased 30 new traffic cameras making it a total of 160
 - Kirwan Contributions
 - Will be higher contributions over the next eight (8) years

- 2. The committee/council members asked questions, stated concerns, asked for clarification, and etc. Some highlights of same were:
 - Several questions regarding Capital Improvement funding
 - Clarification sought regarding the continuation of some programs in fiscal year 2023
 - Current and/or upcoming Inflationary Environment
 - While thinking about spending as it relates to inflation, what is your view on this?
 - Several questions regarding the American Rescue Plan Act (ARPA) spending
 - Nine (9) letter sent out to various agency heads
 - Are we on track with the responses to the letters?
- 3. Hearing called to recessed.

June 1, 2022 – Day One – Budget Hearings

- 1. Four (4) agency representatives came before the committee/councilmembers to talk about his/her fiscal year 2023 budget proposal. Copies of all PowerPoint Presentations are on file
- 2. After each agency head concluded his/her presentation, the committee/council members asked questions, stated concerns, asked for clarification, and etc. And, if applicable went over the responses to letters of information sent to them. Some highlights of same were:
 - I. City Administrator's Office
 - 1. Some areas of discussion by City Administrator Shorter were:
 - Talked about why Office was established
 - How office is staffed
 - Deliveries of the office
 - Talked about key reforms and initiatives
 - Talked about the Mayor's 5 pillars and about some of the highlights in the fiscal year 2023 budget
 - Is holding agencies accountable for service delivery
 - 2. The committee/council members asked questions, stated concerns, asked for clarification, and etc. Some highlights of same were:
 - Questions:
 - o How long have you lived in the City?
 - o Have living in the city affected your job performance?
 - Commitment of \$50 million in capital funding, where is it in your budget?
 - O What commitments do you have to raising capital funding?
 - Procurement Issues
 - How do you feel about removing control of procurement from Mayor's Office to the Comptroller's Office?
 - City Agencies
 - For the agencies that you are responsible for, have you found out what problems exist? And, have those problems been resolved?
 - o Closing 311 tickets too soon need to be revisited
 - Request by Member Stokes: Provided a written narrative regarding: 311 calls being closed too soon. Report back to the committee:
 - What the problems were and how the problems were resolved
 - Where the miscommunications and/or breakdowns occurred, and
 - Recommendations to solve issue(s) at hand

- Summary: Need a better understanding of agency process to identify gaps in service and communication; explain how these gags will be corrected and communicated to constituents.
- o Coordination with agencies to get jobs completed is of concern
- o Equity in city agencies
 - Not all agencies have an Equity Officer is of concern
 - When will these positions be filled?
 - Does the city's Chief Equity Officer have the power to fill these positions?
- Mayor's Office Budget
 - The budget has doubled; the number of positions in the Mayor's Office is of concern
 - Eighty-six (86) positions are now under this Office, will the Office be willing to take on additional responsibilities such as:
 - Water Billing (still seem to be problematic)
 - Solid Waste Issues (recycling collections is of concern)
- Decision Making for Impoverished Communities
 - Concern: there are people in decision making positions making decision for impoverished communities that they have never visited; they need to visit these communities!
- Water Billing
 - A point person for billing issues was assigned in the past!
 - Concern untimely responses to complaints
 - Need timely responses; must empower employees/agencies to response in timely manner; should have someone available to take these issues on.
- Performance and Management Plans
 - Have your office developed any performance and management plans for city agencies?
 - Performance Measures what are you doing differently in this area?
 - How are you going to communicate these plans to city residents?
 - Suggestion: to create a performance management system
 - How have your office worked with agencies that have a "high near retirement employee based?" Do you have a succession plan?
 - Do you know of any efforts of succession plans within agencies?
 - Comments regarding "transfer of knowledge base"
- New Infrastructure Unit to be assigned to your office
 - How will the Unit be funded?
 - Will quarterly reports be available?
 - Suggestion: to take care in creating the job descriptions for employees hired for this Unit
 - Where are you with these positions? What are your recruitment strategies for vacancies?
 - How do you see those agencies who work with infrastructure working with the new office?
 - Partnerships and coordination are essential
 - Talk about your partnerships inside and outside of city government
 - Partnership with BCPS is essential

- Concern Surpluses School Buildings
 - o An immediate plan is needed for when buildings are turned over to the city.
 - o What is in the plan for these surpluses' buildings?
 - These buildings should be consistently maintained.
- Constituent Service Issues/Concerns
 - Who in your office can help with these issues other than you and/or your deputies?
- Comments
 - There seems to be a disconnect between residents and city agencies is of concern
 - Need to force coordination and collaboration between agencies when needed
- Vacant Positions
 - Key positions that are vacant; where are you with this? One position has been vacant for over 3 ½ months. Requested by Chairman Costello: Can you provide some feedback regarding this position?
 - What about the Finance Director's position? Where are you with this?
 - Are there any Deputy Director or higher vacancies currently open?
 - Requested by Chairman Costello: Provide a list for vacant positions for Deputy Directors or higher; to include job descriptions and how long positions been vacant.
- ARPA Funding
 - What amount of funding have been allocated to date?
 - What percentage of this funding is going toward resolving basic city core services?
 - Concern: City services that have come offline and/or at a standstill due to COVID
 - Are there any funds left to get street sweeping started again?
 - Funding for Housing
 - ARPA funding is filling some gaps but it is just not enough!
 - How will the recommendations be allocated?
 - Will a dashboard be available?
 - How will we receive feedback?
- Concerns:
- Creating future unfunded liabilities with ARPA funding
- Backlog in city services (tree stump removals, trash pickup, recycling pickup, etc.)
- Transfer Station(s)
 - Northwest Transfer Station long lines are of concern
 - Is there a plan to address this?
- Procurement Stat
 - o Can you talk about this?
- Future Change to City Council's Authorization Power over Budget
 - o What do you see as your role in the budget process when this change occurs?

 - Stated, "The Capital Budget is based on what the city can afford; not on the many needs of the City of Baltimore"
 - o Explained how the Capital Budget is put together (Processes, timelines, criteria, etc.)
- The committee/council members asked questions, stated concerns, asked for clarification, and etc. Some highlights of same were:

o Deferred Maintenance

- There is over \$1.3 billion of deferred maintenance that needs to be done
- How much ARPA funds is going to maintenance?
- Did you submit request for ARPA funding for any capital projects? Answer:

- Do you think it's a good policy to do business with businesses that are not in good standing with the State? Answer: Would have to look at it on a case by case basis
- When an agency has capital needs do they come to you? Answer: Yes
- What is a target letter?

- Non-profits who don't follow proper processes for receiving funds nor in good standing with the State
- Applicants/Application Process ARPA Applicants
 - O Hoping you are reviewing the background of applicants thoroughly for compliance purposes?

Diverting and Selling Real Estate

- Surplus School Buildings
 - Are you a part of this process and/or have a role in what will go into these buildings?
 - o It seems to be a lot of flaws when handling school buildings
- Assessing City-Owned Buildings
 - o How often are assessments being conducted on city-owned buildings?
 - Some of these buildings are sitting too long is of concern

Flipping Homes Qualified as a Historic Preservation

• When people buy these type homes and don't know that it qualifies as a historic preservation home – is of concern

Impoundment Lot on Pulaski Highway

- Are you familiar with the conditions of this impoundment lot?
- I suggest you visit it!
- It is my understanding that Code Enforcement would not approve improvements to it because it is in the flood plan
- This facility is not safe for employees to work at and is of concern!
- ARPA funding could have been used for a mobile trailer. Or other funding needs to be identified as soon as possible for the safety of our employees

Hillen Road Flooding

- Was glad to see funding allocated to the Hillen Road flooding issue
- How can this issue become a priority for getting the \$20 million additional funds needed to resolve the problem altogether?

Senior/Older Adult Needs

• Is there any capital funding for our seniors who need assistance with things such as roofing repairs, heating systems and etc.?

Zero Waste/Solid Waste/Incinerator

- Are there any plans for our net zero goals by the year 2045?
- When does the contract for the incinerator end?
- We need to start thinking about the long-term cost before the contract ends; having a discussion now instead of later!

Investing in Communities

- Have you thought about how to build up communities by taking small steps or with initiatives? The need is definitely there!
- Would love to work with Planning on plans for a composting facility initiative

Repairs

• If a pipe is broken does the county pay half of the repair costs? Answer: This is a DPW question.

Capital Budget Presentation Today

- In the future can you provide more information in your Presentation?
- Would like to see more of how funds are going out instead of what is coming in; think it would be helpful.

Bicycle Infrastructure

• Requested by Member Dorsey: Provide actually spending on bicycle infrastructure; to include how much is unspent to day

Building Assessments

- What is the lifecycle for assessing all our buildings?
- How is the list prioritized?
- Can the assessments conducted on buildings be changed from every 5 years to being assessed every 2 years instead? And, if the assessments are performed every 2 years the buildings would be much cheaper to maintain.
