ACTION REQUESTED OF B/E:

Approval of General Fund supplemental appropriation in the total amount \$5,375,000 for M-R: Convention Center Hotel, Service #535: Convention Center Hotel, for debt service.

AMOUNT OF MONEY AND SOURCE OF FUNDS:

The source of funds for this appropriation (\$5,375,000) is revenue generated by the City's Recordation Tax:

BACKGROUND AND EXPLANATION:

This action is required to balance the Convention Center Hotel budget for Fiscal 2022. Several revenue types are used to repay debt service for the hotel. First, revenue from the Hotel's property taxes that exceed the base level, as a part of a Tax Increment Financing (TIF) District, and hotel tax revenues are dedicated to debt repayment. Additionally, the hotel's operating revenue is used for annual debt service repayment. If these revenues are insufficient to cover the annual debt service cost, the City must divert up to \$7 million of General Fund Hotel Tax revenue to close the gap.

As of September 2, 2022, the City has recorded \$1.8 million in Hotel Tax revenue for the Convention Center Hotel. This revenue figure only includes Hotel Tax revenue submitted through June 2022. The Convention Center Hotel often submits Hotel Tax revenues several months after the date of collection or in batches which makes it difficult to determine the exact revenue collected during the fiscal year. In FY21 the City collected \$21,328,915 in Hotel Tax revenue and BBMR projects revenue in FY22 and FY23 to total \$26 million and \$26.7 million, respectively.

Although the current estimate for FY23 Hotel Tax anticipates a year over year increase of 2.4%, the FY23 adopted budget included \$7 million for a Hotel subsidy. The actual amount paid may decrease based on revenue receipts.
