- District to the R-8 Zoning District the property known 801 South Haven Street, and from the I-2
- Zoning District to the R-8 Zoning District the properties known as a portion of Block 6458/Lot
- 17 004A, and a portion of Block 6467/Lot 021A, and a portion of Block 6458/Lot 004, as outlined
- in red on the plat accompanying this Ordinance.

1	SECTION 2. AND BE IT FURTHER ORDAINED, That as evidence of the authenticity of the
2	accompanying plat and in order to give notice to the agencies that administer the City Zoning
3	Ordinance: (i) when the City Council passes this Ordinance, the President of the City Council
4	shall sign the plat; (ii) when the Mayor approves this Ordinance, the Mayor shall sign the plat;
5	and (iii) the Director of Finance then shall transmit a copy of this Ordinance and the plat to the
6	Board of Municipal and Zoning Appeals, the Planning Commission, the Commissioner of
7	Housing and Community Development, the Supervisor of Assessments for Baltimore City, and
8	the Zoning Administrator.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
