2	\$1,900,000,00 shall be made available to the Department of Finance - Service 704 (Accounting)
3	as a Supplementary General Fund Operating Appropriation for Fiscal Year 2022, to provide
4	funding for Fiscal Year 2022 expenses. The source of revenue for this appropriation is
5	Recordation Tax in excess of the amount from this source that was relied on by the Board of
6	Estimates in determining the tax levy required to balance the budget for Fiscal Year 2022.

7 SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
