7	Estimates for Fiscal Year 2022 was formulated.		
8	This appropriation is made necessary by a material change in circumstances since the		
9	Ordinance of Estimates for Fiscal Year 2022 was formulated or is for a new program that could		
0	not have been reasonably anticipated when that Ordinance of Estimates was formulated.		
1	On November 2, 2022, the Board of Estimates recommended this appropriation to the City		
2	Council.

1	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
2	\$2,725,000.00 shall be made available to the Department of Public Works - Service 676
3	(Administration - DPW) as a Supplementary General Fund Operating Appropriation for Fiscal
4	Year 2022, to provide funding for Fiscal Year 2022 expenses. The source of revenue for this
5	appropriation is Recordation Transfer Tax in excess of the amount from this source that was
6	relied on by the Board of Estimates in determining the tax levy required to balance the budget for
7	Fiscal Year 2022.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
