Recitals

The revenue appropriated by this Ordinance represents income tax funds in excess of the revenue relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2023.

- 18 This appropriation is made necessary by a material change in circumstances since the
- 19 Ordinance of Estimates for Fiscal Year 2023 was formulated or is for a new program that could 20 not have been reasonably anticipated when that Ordinance of Estimates was formulated.
- On December 21, 2022, the Board of Estimates recommended this appropriation to the City Council.

4 General Fund Capital Appropriation for Fiscal Year 2023, to provide funding for the replacement

5 of CitiWatch cameras. The source of revenue for this appropriation are income tax funds in

6 excess of the amount from this source that was relied on by the Board of Estimates in

7 determining the tax levy required to balance the budget for Fiscal Year 2023.
