Purpose:

For the purpose of calling on the Directors of the Finance Department's Bureau of Budget and Management Research (BBMR), Capital Budget and the Baltimore City Public School to brief the City Council on how the City's actual finances compare to its budget projections.

## **Analysis**

#### **Current Law**

Baltimore City Code - Article 1, Subtitle 1-City Council, 1-6

§ 1-6. Agencies to provide legislative information.

It shall be the duty of the head of every City department or bureau established by the Baltimore City Charter or by ordinance to provide all technical materials, plats, drawings, and information that are requested by any member or the President of the City Council for the purpose of introducing legislation into the Council.

(City Code, 1976/83, art. 1, §6.) (Ord. 76-080.)

## Background

## I. Department of Finance - Budget and Research Management

On May 2, 2023, a representative(s) from the Bureau of Budget and Research Management came before the committee to discuss the second quarter projection for fiscal year (Fiscal Year 2023); October 1, 2022, through December 31, 2022, and to present a revenue forecast for Fiscal Year 2024.

Following are notes from the May 2, 2023, hearing:

#### Major Issues Discussed

- 1. The representatives from BBMR gave a PowerPoint presentation. A copy of the Presentation is on file.

  The Presentation included the following:
  - Second (2<sup>nd</sup>) Quarter Projection for Fiscal Year 2023; ending December 31, 2022
    - Highlights
    - Expenditure Overview
    - Revenue Overview
      - Projected Surpluses
      - Projected Deficits
  - FY 2024 Revenue Projection Fiscal Year 2024 July 1, 2023, through June 30, 2024
    - Revenue Assumptions
- 2. Committee/council members asked questions, stated concerns, and made comments. Some highlighted topics of discussion and/or concern were:
  - High-Performance MRR Tax Credits
    - Questions, concerns, and comments regarding the tax credits
    - President Mosby talked about the importance of the upcoming evaluation of the City's tax credits.
  - FEMA Reimbursement Deadline
    - Talk about this; what happens after the May 11th deadline?
  - Duplicated Records Property Taxes
    - How did this happen? (Duplications)
    - Talk about this.
    - Projected reduction in Revenue for Property Taxes—why the reduction? Talk about this!
  - GMS Software
    - Does Finance have the addresses specifically for the high-performance tax credits?
    - Requested by President Mosby: Please provide the addresses for same for the past five (5) years.

 Requested by Councilmember Ramos: Include in the President's request the "Brownfields" too.

### Vacancies

- Requested by Councilmember Burnett: Provide a breakdown of all vacancies in both the Fire and Police Departments by position and title.
- What is the possibility of having a "wait list" for vacancies in the Fire Department?
- What is the possibility of re-opening the list for vacancies within the Fire Department?
- How are vacancies projected for each agency in the budget?
- Vacancies that stay constant for the past two (2) years; how are they projected in the budget?

## Investment Earnings

- Where are the earnings placed and/or go?
- Are the earnings invested into the market?

## Moving Violations

- Requested by Councilmember Middleton: Provide a breakdown of where revenue is being collected for red light and speeding citations; for locations throughout the city; particularly from the major thoroughfares.
- Health Department Expenditures for housing and/or hotels
  - When will we acquire a hotel for same?
  - In the preliminary budget for FY2024 it shows only a purchase of one hotel: why one and not two hotels? Talk about this!

#### TIF's

- Is showing \$3 million for TIF's can you explain this a little more?
- Requested by Councilmember Ramos: Provide a TIF's analysis for the next five (5) years.

#### Supplementals

- Questions and comments regarding the number of supplementals that came before the Council this year.
- Did the number of supplementals come about as a result of vacancies?

#### Projections

- Talk about the process for coming up with projections for:
  - Excess Revenue
  - Assumptions
  - Approaches
  - About how the Bureau comes up with the projections.
- 3. President Mosby commented about how the Council's role will tie into the budgets in the future.
- 4. Hearing was called to recess.

## III. Baltimore City Public Schools

On February 7, 2023, representative(s) from BCPS came before the committee to discuss their Fiscal Year 2022 financial summary/closeout which ended June 30, 2022. Prior to this hearing, on May 10, 2022, representative(s) from BCPS came before the committee to discuss their third quarter projection for fiscal year 2022; January 1, 2022, through March 31, 2022.

Following are the notes taken during the February 7, 2023, hearing:

## Major Issues Discussed

1. The representative from BCPS gave a PowerPoint presentation. A copy is on file. The Presentation included the following topics:

Fiscal Year 2022 General Fund Revenues as of June 30, 2022

Fiscal Year 2022 General Fund Expenditures as of June 30, 2022

Fiscal Year 2022 Summary of GF Revenue and Expenditures as of June 30, 2022

2. Committee/council members asked questions, stated concerns, and gave comments. Some highlighted topics of discussion and/or concern were:

## Behavioral Health Services

Committee member McCray stated that she is concerned about the behavioral health services that are provided in schools in the Frankford Area of the City; services relating to:

- Trauma
- Mental Health
- Uptick in Youth Violence
- Requested by member McCray: Submit in writing, what the BCPSS is spending on behavioral health.
- Requested by member Stokes Provide the above data for all BCPS(s).
  - Per Mr. Doherty, he will gather the information relating to behavioral health services provided in schools and submit same to committee.
- COVID/Pandemic Backlash Associated with Same
  - What have the BCPSS done to help students with their academics? To getting them back to standards! What are some of your plans for same?
    - Some answers given were:

- Extended School Days
- Summer Programs, and
- Homegrown Tutoring Programs

#### Teacher Shortages

- A representative from the BCPSS talked about the staffing shortages. Some comments were:
  - o Teacher shortage is a national problem.
  - o The BCPSS had approximately 1,300 vacancies this school year; up from 600 vacancies to 1,300!
  - But have hired 700 more teaches this year; but it is not enough!
- Day Care in BCPS
  - A committee member commented, "day care is important for students who are parents!" Where is BCPS on this issue?
    - Response given: Day Care is in some of the school buildings, but BCPS does not run them!
- Older School Buildings
  - Are you looking at all school buildings to see which ones may need additional funding?
- Partnerships
  - Suggestion: BCPS should reach out to some of the organizations within the City for partnerships, such as the Family League.
- 3. Hearing was called to recess.
