On page 1, in line 5, strike "prepare" and substitute "<u>facilitate</u>"; and, on page 3, in line 1, strike "*PREPARATION*" and substitute "<u>FACILITATION</u>"; and, on that same page, in line 2, after "BY", insert "<u>SUBSECTION (B)(1) OF</u>"; and, on that same page, in line 3, strike "PREPARED" and substitute "<u>FACILITATED</u>"; and, on page 4, in line 10, strike "PREPARE" and substitute "<u>ENSURE THAT</u>"; and, on that same page and line, after "<u>BILL</u>", insert "<u>IS PREPARED BY THE RELEVANT AGENCY OR AGENCIES</u>".

Amendment No. 3

On page 2, strike lines 13 through 18 in their entireties and substitute:

Amendment No. 4

On page 2, strike lines 19 through 22 in their entireties and substitute:

"(2) OTHER AGENCY REFERRALS.

IN ADDITION TO THE AGENCIES AND REPORTS SPECIFIED IN PARAGRAPH (1) OF THIS SUBSECTION, THE CITY COUNCIL PRESIDENT MAY, IN THE PRESIDENT'S DISCRETION, REFER THE BILL TO ANY OTHER RELEVANT CITY AGENCY FOR THAT AGENCY'S REPORT ON THE BILL.".

Amendment No. 5

On page 3, in line 4, strike "*TIME FOR SUBMISSION*" and substitute "<u>SUBMISSION</u>; <u>AGENCY</u> <u>COOPERATION</u>"; and, on that same page, strike lines 5 through 16 in their entireties and substitute:

"(1) TIME FOR SUBMISSION.

ANY EQUITY ASSESSMENT, FISCAL NOTE, OR REPORT REQUIRED BY THIS SECTION SHALL BE SUBMITTED TO THE OFFICE OF COUNCIL SERVICES NO LATER THAN 48 HOURS BEFORE THE BILL'S SCHEDULED COMMITTEE HEARING.

(2) AGENCY COOPERATION.

IN ORDER TO FACILITATE THE ANALYSES REQUIRED BY THIS SECTION, ANY DEPARTMENT, AGENCY, BOARD, COMMISSION, COUNCIL, AUTHORITY, COMMITTEE, OFFICE, OR OTHER UNIT OF CITY GOVERNMENT SHALL RESPOND TO ANY REQUEST FOR INFORMATION REGARDING THE FISCAL, EQUITY, OR OPERATIONAL IMPACT OF A BILL WITHIN 3 BUSINESS DAYS OF RECEIPT OF THAT REQUEST.".
