Major Issues Discussed

- 1. Councilwoman Middleton opened the meeting, introduced committee members and City representatives, and read the resolution into the record.
- 2. Councilmember Odette Ramos explained her purpose for sponsoring the resolution and provided information about the history and establishment of the Affordable Housing Trust Fund (AHTF). She explained how advocacy for affordable housing in Baltimore helped to establish a flexible source of funding for low-income residents in order to support more dwelling units, a local voucher program, rental assistance, senior home repairs and affordable homeownership. City recordation and transfer taxes are used as a funding source for AHTF. The City has also committed to using bond funds to support AHTF.
- 3. Alice Kennedy provided a presentation about AHTF. The presentation focused on an overview of the following:
 - History of AHTF
 - Baltimore Households and Income Levels
 - AHTF's Outreach Efforts
 - AHTF's Legal Framework for the Range of Use of Funds
 - o DHCD and the AHTF Commission's Roles and Responsibilities
 - Revenue Collected for the fund for FY 19(Partial), FY 20, FY21(YTD)
 - Revenue Projections
 - o Annual Report
 - o Community Advocates and Equitable Access to AHTF Funding
 - $\circ~$ AHTF's Proposed and Revised Spending Plan for FY '20 FY '22
 - COVID-19's Impact on Revenue
 - Awards of Funding for New Construction/Preservation of Existing Rental Housing NOFA (4 applicants awarded \$2,059,500 in first round)
 - Senior Housing Repair & Preservation Budget (Planned Budget \$3 million)
 - Community Land Trust Funding (several awards made and 6 submissions)
 - Use of Resources for Funded and Committed Projects
 - Legislation Bills 20-0625 (General Counsel for Evictions) and 21-0004 (Office to End Homelessness / Housing Voucher Program)
