# INTRODUCTION AND READ FIRST TIME

The President laid before the City Council the following bills and Resolutions of the Mayor and City Council for first reading:

Bill No. 21-0063 - By Councilmember Cohen

An Ordinance changing the zoning for the property known as 1201 Dundalk Avenue (Block 6738, Lot 036), as outlined in red on the accompanying plat, from the R-3 Zoning District to the C-2 Zoning District.

The bill was read the first time and referred to the City Solicitor, Board of Municipal and Zoning Appeals, Planning Commission, Department of Housing and Community Development, Baltimore Development Corporation, Department of Transportation, and the Economic and Community Development Committee.

# Bill No. 21-0064 - Councilmember Cohen

An Ordinance permitting, subject to certain conditions, the establishment, maintenance, and operation of a retail goods establishment (with alcoholic beverages sales) on the property known as 3901 Boston Street (also known as 3975 Boston Street), as outlined in red on the accompanying plat; and providing for a special effective date.

The bill was read the first time and referred to the City Solicitor, Board of Municipal and Zoning Appeals, Planning Commission, Department of Housing and Community Development, Baltimore Development Corporation, Department of Transportation, and the Economic and Community Development Committee.

# Bill No. 21-0065 - Councilmember Glover

An Ordinance changing the zoning for the property known as 1103-1109 North Washington Street (Block 1551, Lot 001), as outlined in red on the accompanying plat, from the R-8 Zoning District to the IMU-1 Zoning District.

The bill was read the first time and referred to the City Solicitor, Board of Municipal and Zoning Appeals, Planning Commission, Department of Housing and Community Development, Baltimore Development Corporation, Department of Transportation, Parking Authority, and the Economic and Community Development Committee.

**Bill No. 21-0066** - Councilmember Conway, Costello, Stokes, Middleton, Torrence, Ramos, Burnett, Porter, Bullock, President Mosby

An Ordinance prohibiting the new investment of certain retirement funds in fossil fuel companies; requiring the divestment of certain retirement funds in fossil fuel companies within a certain time frame; requiring certain reviews; specifying a certain procedure for the divestiture of investments; authorizing certain exemptions; defining certain terms; and providing for a special effective date.

The bill was read the first time and referred to the City Solicitor, Department of Finance, Employees' Retirement System, Fire and Police Employees' Retirement System, Retirement Savings Plan, Labor Commissioner, Department of Human Resources, and the Public Safety and Government Operations Committee.

**Bill No. 21-0067** - Councilmember McCray, Porter, Middleton, Ramos, Bullock, Torrence, Cohen, Stokes

An Ordinance prohibiting a re-organization or shift in staff reporting requirements in order to purposefully evade the Baltimore City residency requirements; and establishing that a violation of that prohibition is an ethics violation enforceable under the City Ethics Code.

The bill was read the first time and referred to the City Solicitor, Department of Finance, Labor Commissioner, Department of Human Resources, Ethics Board, and the Public Safety and Government Operations Committee.

**Bill No. 21-0068** - President Mosby, Councilmember Middleton, Ramos, Bullock, Stokes, Torrence, McCray, Porter, Cohen, Glover, Burnett

An Ordinance permitting the City Purchasing Agent to waive minor irregularities in bids; permitting a bidder to cure mistakes in a bid under certain conditions; permitting a bidder to withdraw a bid under certain conditions; defining certain terms; requiring the City Purchasing Agent to prepare a determination showing the relief that was granted or denied regarding a bid's correction or withdrawal; and clarifying the duties of the City Purchasing Agent notwithstanding this subtitle.

The bill was read the first time and referred to the City Solicitor, Department of Finance, Planning Department, Department of Public Works, Department of General Services, Minority and Women's Business Development Office, Minority and Women's Business Opportunity Office, and the Public Safety and Government Operations Committee.

**Bill No. 21-0069** - Councilmember Glover, President Mosby, Councilmember Stokes, Cohen, Bullock, Burnett, Ramos, McCray, Torrrence, Middleton, Schleifer

An Ordinance adding certain disclosure requirements related to fulfillment of detailed specifications for contracts, prior contracting experience, and the demographic characteristics of employees, other sources of labor, and board members of contractors and subcontractors for City contracts over \$100,000; defining certain terms; establishing certain administrative penalties; and generally relating to better transparency in Baltimore City procurement.

The bill was read the first time and referred to the City Solicitor, Department of Finance, Labor Commissioner, Minority and Women's Business Development Office, Minority and Women's Business Opportunity Office, and the Public Safety and Government Operations Committee.

**Bill No. 21-0070** - Councilmember Burnett, President Mosby, Councilmember Middleton, Bullock, Torrence, Porter, Stokes, Ramos, Glover, Cohen

An Ordinance requiring contracting agencies to conduct market research investigations before determining that no qualified certified business enterprises are available to enter into

leases or concession contracts; requiring the Minority and Women's Business Opportunity Office to attempt to identify qualified certified business enterprises if contracting agencies state that no qualified certified business enterprises are available to enter into leases or concession contracts; requiring the Minority and Women's Business Opportunity Office to notify the contracting agency and the Board of Estimates if the Office identifies qualified certified business enterprises that are available to enter into leases or concession contracts; requiring contracting agencies that want to waive or reduce MBE/WBE contract goals to conduct market research and document the market research to demonstrate why it is necessary to waive or reduce MBE/WBE contract goals; requiring the Minority and Women's Business Opportunity Office, if granting the waiver or reduction of contract goals, to give the waiver or reduction of contract goals and the accompanying market research documentation to the Board of Estimates; requiring contracting agencies that want to waive utilization requirements for a specific contract to conduct market research and document the market research to demonstrate that needed goods and services are only available from a sole source; requiring the Minority and Women's Business Opportunity Office, if granting the waiver of utilization requirements for a specific contract because the needed goods and services are only available from a sole source, to give the waiver and the accompanying market research documentation to the Board of Estimates; defining a certain term; and making the Board of Estimates the ultimate arbiter regarding the reduction or waiver of MBE/WBE contract goals and utilization requirements.

The bill was read the first time and referred to the City Solicitor, Department of Finance, Labor Commissioner, Minority and Women's Business Development Office, Minority and Women's Business Opportunity Office, and the Public Safety and Government Operations Committee.

The President laid before the City Council the following Council Resolutions for first reading:

Bill No. 21-0040R - By Councilmember Conway, Porter, Middleton, Bullock, McCray, Torrence

A Resolution inviting the Director of the Department of Planning, the Commissioner of the Department of Housing and Community Development, the Executive Director of the Housing Authority of Baltimore City, the Commissioner of the Baltimore City Health Department, the Commissioner of the Baltimore Police Department, the Acting Director of the Department of Public Works, the Director of the Department of Transportation, the Chief of the Baltimore City Fire Department, the State's Attorney for Baltimore City, the Sheriff for Baltimore City, the Chief of the Baltimore City School Police, the Director of the Department of General Services, the Director of the Department of Recreation and Parks, and the Director of the Mayor's Office of Performance and Innovation to appear before the Baltimore City Council to discuss ways that the City can prevent crime through the concepts utilized in the Crime Prevention through Environmental Design model.

The resolution was read the first time and referred to the City Solicitor, Department of Housing and Community Development, Department of Transportation, Baltimore Police Department, Baltimore City Health Department, Baltimore City Sheriff, Planning Department, Department of Public Works, Baltimore City Fire Department, Baltimore City State's Attorney's Office, Baltimore City Public School System, Department of Recreation and Parks, Department of General Services, Mayor's Office of Performance and Innovation, Housing Authority of Baltimore City, and the Public Safety and Government Operations Committee.

**Bill No. 21-0041R** - By Councilmember Conway, Porter, Middleton, Ramos, Bullock, McCray, Torrence, Burnett

A Resolution inviting representatives from the Baltimore City State's Attorney's Office, the Baltimore Police Department, the Mayor's Office of Neighborhood Safety and Engagement, the Health Department, the Sheriff's Office, as well as community advocates fighting against domestic violence to share their expertise with the Baltimore City Council and the general public and to discuss programs available to victims of domestic violence.

The resolution was read the first time and referred to the City Solicitor, Baltimore Police Department, Baltimore City Health Department, Mayor's Office of Neighborhood Safety and Engagement, Mayor's Office of Children and Family Success, Sheriff's Office, State's Attorney's Office, and the Public Safety and Government Operations Committee.

# A Council Resolution Concerning

# Downtown Management Authority - Composition -Member Selected by the Baltimore City Council

FOR the purpose of selecting and approving Councilmember Eric T. Costello to represent the Baltimore City Council on the Downtown Management Authority's Board of Directors pursuant to City Code Article 14, Section 1-7(e)(3).

# **Recitals**

City Code Article 14, Subtitle 1 authorizes the creation of the Downtown Management District (the "District") and the Downtown Management Authority (the "Authority"), subject to certain terms, conditions, and limitations.

The Code also establishes that a Board of Directors shall oversee and govern the Authority. Among other Board positions, the Code requires that "1 member shall be selected by and approved through Resolution of the City Council." *See* Art. 14, § 1-7(e)(3).

As such, the Council finds that there is no better councilmember to fill such a role than the councilmember who represents downtown Baltimore, Councilmember Eric T. Costello. Councilmember Costello has ably represented Baltimore's 11<sup>th</sup> District since 2014 and since that time has dutifully served on the Board of the Downtown Management Authority. Indeed, Councilmember Costello knows downtown, its role as the economic engine of the City and the State, and its long- and short-term challenges better than most anyone in City government.

**Now, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE**, That the Council selects and approves Councilmember Eric T. Costello to represent the Baltimore City Council on the Downtown Management Authority's Board of Directors pursuant to City Code Article 14, Section 1-7(e)(3).

**AND BE IT FURTHER RESOLVED**, That a copy of this Resolution be sent to the Mayor, the President of the Board of Directors of the Downtown Management Authority, the Executive Director of the Downtown Management Authority, and the Mayor's Legislative Liaison to the Baltimore City Council.

Councilmember Middleton made a motion, which was duly seconded, that the Rules be suspended.

There being no objection, the President declared that the Rules were suspended.

Then Councilmember Middleton made a motion, which was duly seconded, that the Resolution be adopted.

#### COMMITTEE REPORTS

# BILL NO. 21-0026 REPORTED FAVORABLY AND ORDERED PRINTED FOR THIRD READING

Councilmember Middleton, for the Economic and Community Development Committee, reported that the Committee has complied with the Land Use Article of the Maryland Code and recommends the adoption of Bill No. 21-0026 favorably.

An Ordinance changing the zoning for the property known as 1201 South Caton Avenue (Block 2108C, Lot 002), as outlined in red on the accompanying plat, from the EC-1 Zoning District to the I-1 Zoning District; and providing for a special effective date.

# **Findings of Fact**

# City Council Bill No. 21-0026

# **Rezoning – 1201 South Caton Avenue**

Upon finding as follows with regard to:

# (1) Population changes;

There has not been a significant change in population in the immediate area that would affect this proposal in any material way. Overall, the City has been losing industrially zoned land in recent years, and this would provide for an additional property that is appropriately sized and shaped, and that is desirable for light industrial uses.

# (2) The availability of public facilities;

This area is served by City utilities that are adequate for a wide range of uses and intensity of redevelopment.

# (3) Present and future transportation patterns;

This area is a part of the City's street grid, and will not negatively impact transportation or traffic patterns. South Caton Avenue is listed as a Through Truck Route by the Department of Transportation.

# (4) Compatibility with existing and proposed development for the area;

As this property is located at the intersection of South Caton Avenue and I-95, this site is well suited to warehouse and distribution center use, as trucks will have immediate

highway access, and will not need to cross through residential areas to do so. It is also contiguous to additional I-1 zoned land to the east and west, bordering the I-95 corridor.

(5) The recommendations of the City agencies and officials, including the Baltimore City Planning Commission and the Board of Municipal and Zoning Appeals;

The Planning Commission voted unanimously to recommend passage of the bill. The Board of Municipal Zoning Appeals defers to the Planning Commission. The City agencies to which the bill was referred made the following recommendations:

(6) The proposed amendment's relationship to and consistency with the City's Comprehensive Master Plan.

The Comprehensive Master Plan's EARN Goal 1, Objective 1: Retain and Attract Businesses in all Growth Sectors. Following rezoning, the Property would be eligible for redevelopment, which has the potential to create a significant number of new jobs in this community.

(7) Existing uses of property within the general area of the property in question;

This property is adjacent to the former Cardinal Gibbons campus that is being redeveloped for mixed commercial and potentially residential use. The proposed I-1 zone will be compatible with the existing and future development for this area, and is positioned to take advantage of its placement at an interstate highway intersection.

(8) The zoning classification of other property within the general area of the property in question;

This property would join two I-1 zones along the I-95 corridor to the east and west. The adjacent C-2 and OR-2 will not be negatively impacted by the proposed rezoning. The only adjacent residentially-zoned land is an R-6 to the west across South Caton Avenue, which is a large multi-family senior-housing complex and the related services (Jenkins Senior Living, The Neighborhoods at St. Elizabeth, Caritas House, St. Ann Day Services,

and DePaul House). The R-3 zone on the south side of I-95 is separated from the proposed rezoning by the highway's cloverleaves (some 750' across), and it will not be directly affected by 1201 South Caton Avenue.

(9) The suitability of the property in question for the uses permitted under its existing zoning classification:

This property is perfectly suited for light industrial use, as it will connect existing I-1 land, and is placed right at the interstate highway intersection, which is advantageous for the proposed warehouse/distribution uses.

(10) The trend of development, if any, in the general area of the property in question, including changes, if any, that have taken place since the property in question was placed in its present classification;

The most recent developments in the area are on the campus of St. Agnes Hospital, and the mixed-use development around the Babe Ruth Field at Cardinal Gibbons. The surrounding neighborhood has been stable, with little other development in recent years.

(11) For a rezoning based on a SUBSTANTIAL CHANGE IN THE CHARACTER OF THE NEIGHBORHOOD, the following facts establish the substantial change since the time of the last comprehensive rezoning:

Department of Planning staff recommends that the Planning Commission find that there has been a significant change in the character that would support the requested rezoning. The closure of the Seton Keough High School occurred just at the end of the Comprehensive Rezoning process of the City, which was voted through Council in December of 2016, later to take effect in June of 2017. In the several years since, there has been no interest for any educational institution to use this property. If the property is not viable for educational use, then the EC-1 Educational Campus zoning is no longer appropriate. For this reason, staff recommends approval of this bill.

(12) For a rezoning based on a MISTAKE in the existing zoning classification, the following facts establish that at the time of the last comprehensive zoning the Council failed to consider then existing facts, or projects or trends which were reasonably foreseeable and/or that events occurring subsequent to the comprehensive zoning have proven that the Council's initial premises were incorrect:
