**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That the name of Barclay Elementary/Middle School (School 54), located at 2900 Barclay Street, is changed to Gertrude S. Williams Barclay School.

**Section 2. And be it further ordained,** That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
