An Ordinance concerning **Landmark List - Clifton School** For the purpose of designating the Clifton School, 2670 Kennedy Avenue, as an historical landmark: exterior.

By adding

Article 6 - Historical and Architectural Preservation
Section 18A-1, to be under the new subtitle "Subtitle 18A. Landmark List: Exteriors - 2020s"
Baltimore City Code
(Edition 2000)

Section 1. Be it ordained by the Mayor and City Council of Baltimore, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 6. Historical and Architectural Preservation

Subtitle 18A. Landmark List: Exteriors - 2020s

§ 18A-1. Clifton School.

Clifton School, 2670 Kennedy Avenue.

Section 2. And be it further ordained, That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.

Section 3. And be it further ordained, That this Ordinance takes effect on the 30th day after the date it is enacted.
