### **A Bill Entitled**

An Ordinance concerning

#### **Repeal - Reisterstown Plaza Transit Station Urban Renewal Area and Plan**

For the purpose of repealing Ordinance 09-219, which established the Reisterstown Plaza Transit Station Urban Renewal Area and Plan; and providing for a special effective date.

By repealing

Ordinance 09-219

**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That Ordinance 09-219 is repealed, and the authority conferred in that Ordinance to establish the Reisterstown Plaza Transit Station Urban Renewal Area and Plan is rescinded.

**Section 2. And be it further ordained,** That this Ordinance takes effect on the date it is enacted.
