### A Bill Entitled

### An Ordinance concerning RPP Area 26 (Campbell Lane) - Revisions

For the purpose of altering the applicable block faces included in Residential Parking Plan Area 26 (Campbell Lane); and altering the hours of applicable parking restrictions to be consistent with a prior Parking Authority of Baltimore City administrative order.

By authority of

Article 31 - Transit and Traffic Section 10-18(a) Baltimore City Code (Edition 2000)

By repealing and re-ordaining, with amendments Parking Management Plan Restatement for Residential Permit Parking Area 26 - Campbell Lane Sections I and II Baltimore Parking Authority

Section 1. Be it ordained by the Mayor and City Council of Baltimore, That Sections I and II of the Parking Management Plan for Residential Permit Parking Area 26 - Campbell Lane read as follows:

#### Residential Permit Parking Program Parking management Plan Restatement RPP Area 26-Campbell Lane

# I. A Residential Permit Parking Program Area known as Area 26, governed by Article 31, Subtitle 10, of the Baltimore City Code, exists for the block faces of the streets listed below:

500 block of Campbell Lane, [odd side only,] both sides, both sides posted

### [II. The parking restrictions that will be posted and enforced in Area 26 is:]

[Two Hour Parking Limit / 7:00am - 7:00pm Monday through Friday / Except with Area #26 Permit]

### ii. Parking restrictions:

### A. In general.

Except as provided in item B., the parking restrictions that will be posted and enforced in Area 26 is Two Hour Parking Limit / 7:00am - 12:00 am Monday through Friday / Except with Area #26 Permit

### **B.** Exception.

The parking restrictions that will be posted and enforced in Area 26, 500 block of Campbell Lane, even side only, is Three Hour Parking Limit / 7:00am - 12:00am Monday through Friday / Except with Area #26 Permit

Section 2. And be it further ordained, That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
