An Ordinance concerning

#### **Sale of Property - 711 North Arlington Avenue (Block 0104, Portion of Lot 062)**

For the purpose of authorizing the Mayor and City Council of Baltimore to sell, at either public or private sale, all its interest in certain property located at 711 North Arlington Avenue (Block 0104, Portion of Lot 062) and no longer needed for public use; and providing for a special effective date.

**Section 1. Be it ordained by the Mayor and City Council of Baltimore,** That, in accordance with Article V, § 5(b) of the City Charter, the City Comptroller may sell, at either public or private sale, all the interest of the Mayor and City Council of Baltimore in the property located at 711 North Arlington Avenue (Block 0104, Portion of Lot 062), and more particularly described as follows:

The subject parcel (711 North Arlington Avenue (Block 0104, Portion of Lot 062)) is part of the Harlem inner block parks, containing 9,140 square feet, more or less, this property being no longer needed for public use.

**Section 2. And be it further ordained,** That no deed may pass under this Ordinance unless the deed has been approved by the City Solicitor.

**Section 3. And be it further ordained,** That this Ordinance takes effect on the date it is enacted.
