Article 6 - Historical and Architectural Preservation Sections 18A-4 Baltimore City Code (Edition 2000)

Section 1. Be it ordained by the Mayor and City Council of Baltimore, That the Laws of Baltimore City read as follows:

Baltimore City Code

Article 6. Historical and Architectural Preservation

Subtitle 18A. Landmark List: Exteriors - 2020s

§ 18A-4. Harlem Theater

Harlem Theater, 616 North Gilmor Street (Block 0110, Lot 008).

Section 2. And be it further ordained, That this Ordinance takes effect on the 30th day after the date it is enacted.
