Article 6 - Historical and Architectural Preservation Sections 18A-5 Baltimore City Code (Edition 2000)

**Section 1. Be it ordained by the Mayor and City Council of Baltimore**, That the Laws of Baltimore City read as follows:

## **Baltimore City Code**

#### Article 6. Historical and Architectural Preservation

Subtitle 18A. Landmark List: Exteriors - 2020s

### § 18A-5. Canton Railroad Transfer Bridge

Canton Railroad Transfer Bridge, Improvement Only Parcel: Ward 01, Section 10, Block 1902-F, Lot 001.

Section 2. And be it further ordained, That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
