# **Section 1. Be it ordained by the Mayor and City Council of Baltimore**, That the Laws of Baltimore City read as follows:

### Subtitle 18A. Landmark List: Exteriors - 2020s

### § 18A-2. Reed Calloway House.

Reed Calloway House, 1316 North Carey Street.

Section 2. And be it further ordained, That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
