AN ORDINANCE concerning 1 **Tax Credits – Portable Homestead** 2 FOR the purpose of establishing a property tax credit for a dwelling newly purchased by a 3 homeowner who has previously received, for a certain period, the homestead property tax 4 5 credit; providing for the amount, duration, and termination of the credit; imposing certain qualifications for and limitations and conditions on the credit; providing for the calculation of 6 the local homestead tax credit on termination of the credit; defining certain terms; and 7 generally relating to the implementation of a portable homestead tax credit. 8 9 BY adding Article 28 - Taxes 10 Section(s) 10-1.1 11 Baltimore City Code 12 (Edition 2000) 13 SECTION 1. 11 12 13 14 15	IN ACCORDANCE WITH STATE TAX-PROPERTY ARTICLE, § 9-304(G), A TAX CREDIT IS GRANTED AGAINST THE CITY PROPERTY TAX IMPOSED ON A DWELLING THAT IS NEWLY PURCHASED BY A HOMEOWNER WHO, FOR THE PRECEDING 5 TAX YEARS, HAS RECEIVED A CREDIT UNDER STATE TAX-PROPERTY ARTICLE, § 9–105 {"HOMESTEAD TAX CREDIT"} FOR A DWELLING LOCATED IN BALTIMORE CITY.

5 6 7	EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, THE CREDIT GRANTED UNDER THIS SECTION IS A FIXED AMOUNT OF \$4,000, TO BE ALLOCATED AND APPLIED OVER A PERIOD OF 5 TAX YEARS AS FOLLOWS:
8	(I) \$1,000 IN THE 1ST TAX YEAR;
9	(II) \$900 IN THE 2^{ND} TAX YEAR;
10	(III) 800 in the 3^{RD} tax year;
11	(IV) 700 in the 4^{th} tax year; and
12	(V) 600 in the 5 th tax year.
13	(2) DWELLING WITHIN LOW OR MODERATE INCOME CENSUS TRACT.
14 15 16 17 18	(I) FOR APPLICATIONS FILED ON OR AFTER OCTOBER 1, 2015, THE FIXED AMOUNT OF THE CREDIT IS \$5,000 FOR A HOMEOWNER WHO PURCHASES A DWELLING LOCATED WITHIN A LOW OR MODERATE INCOME CENSUS TRACT, AS DESIGNATED FROM TIME TO TIME BY THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT AND IN WHICH AT LEAST 51% OF THE PERSONS LIVING IN THE TRACT ARE IN
19	HOUSEHOLDS EARNING 80% or less of the area median income.
20 21 22 23 24 25 26	(II) A HOMEOWNER WHO WAS RESIDING WITHIN A LOW OR MODERATE INCOME CENSUS TRACT, AS DESCRIBED IN SUBPARAGRAPH (I) OF THIS PARAGRAPH, WHEN THE HOMEOWNER SUBMITTED THE APPLICATION FOR THE CREDIT REMAINS ELIGIBLE FOR THE HIGHER CREDIT AUTHORIZED BY THIS PARAGRAPH EVEN IF, AFTER THE DATE OF THE APPLICATION, THE CENSUS TRACT CHANGES AND THE HOMEOWNER WOULD OTHERWISE BE INELIGIBLE FOR THE HIGHER CREDIT DURING THE 5–YEAR PERIOD.

7 8 9 10 11	A HOMEOWNER MAY NOT RECEIVE A CREDIT UNDER THIS SECTION (OR PORTION OF THE CREDIT) FOR ANY YEAR IN WHICH APPLICATION OF THE CREDIT (OR PORTION OF THE CREDIT) WOULD REDUCE THE HOMEOWNER'S PROPERTY TAX LIABILITY BELOW THE HOMEOWNER'S PROPERTY TAX LIABILITY FOR THE DWELLING PREVIOUSLY OCCUPIED BY THE HOMEOWNER.

19 20	THE CREDIT GRANTED UNDER THIS SECTION FOR A DWELLING MAY NOT BE TRANSFERRED TO:
21 22	 (I) A PERSON WHO PURCHASES THE DWELLING FROM THE HOMEOWNER RECEIVING THE CREDIT; OR
23 24	(II) A DWELLING THAT IS SUBSEQUENTLY PURCHASED BY THE HOMEOWNER RECEIVING THE CREDIT.
25	(H) LOCAL PORTION OF HOMESTEAD CREDIT.
26 27 28	AFTER TERMINATION OF THE CREDIT GRANTED UNDER THIS SECTION, A HOMEOWNER IS ENTITLED TO THE LOCAL PORTION OF THE CREDIT GRANTED UNDER STATE TAX-PROPERTY ARTICLE, § $9-105$ {"Homestead tax credit"}, which shall be calculated:
29 30	(1) AS IF THE HOMEOWNER HAD RECEIVED THE CREDIT UNDER § 9–105 BEGINNING IN THE SECOND YEAR THE HOMEOWNER OCCUPIED THE DWELLING; AND

4 5	THE FINANCE DIRECTOR SHALL REVIEW AND APPROVE APPLICATIONS FOR THE CREDIT GRANTED UNDER THIS SECTION BASED ON:
6 7	(1) THE AVAILABILITY OF THE FUNDS APPROPRIATED FOR THE CREDIT AND ITS ADMINISTRATION UNDER STATE TAX-PROPERTY ARTICLE, § 9-304(G)(9)(I); AND
8	(2) THE ORDER IN WHICH APPLICATIONS FOR THE CREDIT ARE RECEIVED; AND
9	(J) RULES. REGULATIONS, AND PROCEDURES.
10 11	THE FINANCE DIRECTOR SHALL ADOPT RULES, REGULATIONS, AND PROCEDURES AS NECESSARY TO CARRY OUT THIS SECTION.
12	(K) <i>REPORTING</i> .
13 14 15	THE DEPARTMENT OF FINANCE SHALL EVALUATE THE EFFICACY OF THE CREDIT ESTABLISHED BY THIS SECTION AND SUBMIT A REPORT OF ITS FINDINGS AND RECOMMENDATIONS ON OR BEFORE DECEMBER 31, 2018, AND DECEMBER 31, 2020, TO:
16	(1) THE MAYOR AND THE CITY COUNCIL; AND
17	(2) IN ACCORDANCE WITH STATE GOVERNMENT ARTICLE, § 2–1246:
18	(I) THE BALTIMORE CITY HOUSE DELEGATION;

23	(L) TERMINATION OF PROGRAM.
24 25	(1) NEW CREDITS MAY NOT BE GRANTED UNDER THIS SECTION FOR ANY TAX YEAR BEGINNING ON OR AFTER JULY 1, 2020.
26 27 28 29	(2) THIS SUBSECTION DOES NOT APPLY TO AN OWNER'S CONTINUED RECEIPT OF AN ANNUAL CREDIT, AS PROVIDED IN SUBSECTION (D) OF THIS SECTION, WITH RESPECT TO A PROPERTY FOR WHICH THE TAX CREDIT WAS INITIALLY GRANTED AND RECEIVED FOR A TAX YEAR ENDING ON OR BEFORE JUNE 30, 2020.

SECTION 2. AND BE IT FURTHER ORDAINED, That the catchlines contained in this Ordinance
 are not law and may not be considered to have been enacted as a part of this or any prior
 Ordinance.

SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on October 1,
 2014.
