INTRODUCTION AND READ FIRST TIME

The President laid before the City Council the following bills and Resolutions of the Mayor and City Council for first reading:

Bill No. 0121 - By City Council President (Administration)

An ordinance authorizing the Mayor and City Council of Baltimore to grant 2 Perpetual Easements to the Maryland State Highway Administration for the maintenance of 2 storm water drainage inlets along Dulaney Valley Road, through the property of the Loch Raven Reservoir, in Baltimore County, Maryland, as shown on Plat 61536 filed in the State Highway Administration State Roads Commission; and providing for a special effective date.

The bill was read the first time and referred to the Economic and Community Development Committee.

Bill No. 21-0122 - By City Council President (Administration)

An ordinance granting a franchise to The Johns Hopkins University (Developer's Agreement #1710) to construct, use, and maintain 5 utilities/ductbanks, subject to certain terms, conditions, and reservations; and providing for a special effective date.

The bill was read the first time and referred to the Economic and Community Development Committee.

Bill No. 21-0123 - By City Council President (Administration)

An ordinance granting a franchise to the State of Maryland (Maryland Transit Administration) to construct, use, and maintain an underground conduit and fiber optic cable, subject to certain terms, conditions, and reservations; and providing for a special effective date.

The bill was read the first time and referred to the Economic and Community Development Committee.

Bill No. 21-0124 - By City Council President (Administration)

An ordinance repealing the many definitions and rules of statutory interpretation and time computation that have been superseded by the enactment of Code-wide, standardized definitions and rules; clarifying certain purposeful variations; and providing for a special effective date.

The bill was read the first time and referred to the Rules and Legislative Oversight Committee.

Bill No. 21-0125 - By Councilmember Dorsey

An ordinance making certain substantive and technical revisions to Article 15 {"Licensing and Regulation"}, Subtitle 22 {"Towing Services - Trespass Towing"}; establishing certain maximum charges for towing services; specifying certain required information to be included on towing service receipts and on daily logs maintained by each towing service; specifying certain limitations on incomplete tows; requiring that a towing service must accept credit cards; prohibiting certain instances of patrol towing; making certain stylistic changes; conforming, clarifying, and correcting related provisions; and generally related to the regulation of trespass towing services in Baltimore City.

The bill was read the first time and referred to the Rules and Legislative Oversight Committee.

Bill No. 21-0059R - By Councilmember Bullock

A Resolution providing the required approval under Md. Code Ann., Alc. Bev. §12-902.1(d)(1) to allow the license holder holding a valid Class B-D-7 Beer, Wine, and Liquor License issued for use at 604 Poplar Grove Street, Baltimore, Maryland 21216 to apply to the Board of Liquor License Commissioners for Baltimore City to exchange their Class B-D-7 Beer, Wine, and Liquor License for a Class A-7 Beer, Wine, and Liquor License.

The bill was read the first time and assigned to the Economic and Community Development Committee.

Bill No. 21-0060R - By Councilmember Bullock

A Resolution providing the required approval under Md. Code Ann., Alc. Bev. § 12-902.1(d)(1) to allow the license holder holding a valid Class B-D-7 Beer, Wine, and Liquor License issued for use at 1901 Edmondson Avenue, Baltimore, Maryland 21223 to apply to the Board of Liquor License Commissioners for Baltimore City to exchange their Class B-D-7 Beer, Wine, and Liquor License for a Class A-7 Beer, Wine, and Liquor License.

A COUNCIL RESOLUTION CONCERNING

Childhood Cancer Awareness Month

FOR the purpose of declaring September Childhood Cancer Awareness Month, honoring the children whose lives have been lost to cancer, offering condolences to the families of those children, celebrating survivors, and advocating for more research on the prevention and treatment of pediatric cancer.

Recitals

In September 2019, Congress passed a resolution making September Childhood Cancer Awareness Month. According to the American Childhood Cancer Association, 1 in 285 children in the United States will be diagnosed with cancer before the age of 20 years old. Cancer is the leading cause of death by disease in American children. The causes of most pediatric cancers are unknown and likely not preventable. Each year, an estimated 15,780 children aged 0-19 in the

United States alone will be diagnosed with a form of childhood cancer. Approximately 40,000 American children are in active treatment at any given time.

Only 4% of all cancer research dollars are spent to cure cancer in children. The Children's Cancer Foundation, located here in Maryland, estimates that less money is spent on pediatric cancer research for than on the production of 1 major motion picture. Since 1980, hundreds of cancer drugs have been approved for adults, but only 12 have been approved for use in children, and only 3 have been developed specifically for children.

According to the National Cancer Institute, two-thirds of childhood cancer survivors are at risk for or experience side effects such as secondary cancers, heart damage, lung damage, infertility, chronic hepatitis, alterations in growth and development, impaired cognitive abilities, and psycho-social impairments like severe anxiety and behavioral problems. Families who have experienced or been affected by childhood cancer continue to advocate for more awareness, funding, and research for prevention and treatment. No parent deserves to hear those 4 horrible words, "Your child has cancer."

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, That the City Council declares September Childhood Cancer Awareness Month, honors the children whose lives have been lost to cancer, offers condolences to the families of those children, celebrates survivors, and advocates for more research on the prevention and treatment of pediatric cancer.

AND BE IT FURTHER RESOLVED, That a copy of this Resolution be sent to the Mayor and the Mayor's Legislative Liaison to the City Council.

**BILL NO. 21-0030 REPORTED FAVORABLY, WITH AMENDMENTS,
AND ORDERED PRINTED FOR THIRD READING**

Councilmember Conway, for the Public Safety and Government Operations Committee, reported Bill No. 21-0030 favorably, with amendments.

An Ordinance requiring that the City Administrator coordinate a multi-agency code inspection after a commercial property has been issued certain environmental citations; requiring that the City Administrator and the Department of Housing and Community Development receive a copy of all environmental citations issued; specifying which agencies must be included

in the multi-agency inspection team; requiring that the City Administrator provide certain information to councilmembers; requiring that the City Administrator submit an annual report detailing the work of the multi-agency inspection team; and providing for a special effective date.

Committee Amendments to City Council Bill No. 21-0030

Amendment No. 1

On page 1, in line 3, strike “requiring that” and substitute “permitting”; and, in that same line, after “Administrator”, insert “to”.

Amendment No. 2

On page 1, strike lines 11 through 20 in their entirety and substitute:

“By adding

Article 1 - Mayor, City Council, and Municipal Agencies
Section(s) 58-1 to 58-6, to be under the new subtitle designation,
“Subtitle 58. Coordinated Multi-Agency Code Inspections”
Baltimore City Code

“SUBTITLE 58. COORDINATED MULTI-AGENCY CODE INSPECTIONS

§58-1. SCOPE OF SUBTITLE.

THIS SUBTITLE ONLY APPLIES TO ENVIRONMENTAL CITATIONS ISSUED TO
COMMERCIAL PROPERTIES FOR VIOLATIONS OF:

(1) ARTICLE 19, SUBTITLE 32 {“MINORS – SALES IN PROXIMITY TO LIQUOR
STORE”};

- (2) ARTICLE 23 {"SANITATION"};
- (3) TITLE 5, SUBTITLE 2 {"NUISANCE ABATEMENT"} OF THE HEALTH CODE;
- (4) TITLE 7 {"WASTE CONTROL"} OF THE HEALTH CODE;
- (5) TITLE 12 {"TOBACCO PRODUCTS AND SMOKING DEVICES"} OF THE HEALTH CODE; OR
- (6) TITLE 15 {"EPHEDRINE PRODUCTS"} OF THE HEALTH CODE.

§58-2. RETENTION OF RECORDS.

THE ORIGINAL OR A COPY OF A CITATION LISTED IN §58-1 OF THIS SUBTITLE MUST BE FILED AND RETAINED IN THE RECORDS OF:

- (1) THE CITY ADMINISTRATOR; AND
- (2) THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT FOR INCLUSION IN ITS OPEN DATA MAPPING APPLICATION."

§58-3. COORDINATION OF RESPONSE.

WITHIN 30 DAYS OF RECEIPT OF AN ENVIRONMENTAL CITATION DESCRIBED IN §58-1 OF THIS SUBTITLE, THE CITY ADMINISTRATOR MAY COORDINATE A MULTI-AGENCY, COMPREHENSIVE CODE INSPECTION OF THE CITED PREMISES, AS SPECIFIED IN SUBSECTION §58-4 OF THIS SUBTITLE.

§58-4. MULTI-AGENCY INSPECTION TEAM.

(A) COMPOSITION.

THE MULTI-AGENCY INSPECTION TEAM COORDINATED BY THE CITY ADMINISTRATOR UNDER THIS SUBTITLE SHALL INCLUDE REPRESENTATIVES FROM:

- (1) THE FIRE DEPARTMENT;
- (2) THE DEPARTMENT OF HEALTH; AND
- (3) THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT.

(B) DUTIES.

Journal of the City Council

EACH AGENCY SPECIFIED IN THIS SECTION SHALL INSPECT THE PREMISES TO ENSURE COMPLIANCE WITH LAWS, RULES, AND REGULATIONS ADMINISTERED BY THAT AGENCY.

§58-5. MONTHLY NOTICE TO COUNCILMEMBERS.

NO LATER THAN THE 1ST OF EACH MONTH, THE CITY ADMINISTRATOR SHALL INFORM EACH COUNCILMEMBER OF THE NUMBER AND SPECIFIC LOCATIONS OF ANY MULTI-AGENCY INSPECTIONS CONDUCTED, IF ANY, PURSUANT TO THIS SUBTITLE IN THE PREVIOUS MONTH WITHIN THE RESPECTIVE COUNCILMEMBER'S DISTRICT.

§58-6. QUARTERLY REPORT.

THE CITY ADMINISTRATOR SHALL SUBMIT A QUARTERLY REPORT TO THE MAYOR AND CITY COUNCIL DETAILING:

- (1) THE NUMBER OF MULTI-AGENCY COORDINATED INSPECTIONS CONDUCTED UNDER THIS SUBTITLE OCCURRING IN THE PREVIOUS QUARTER;
- (2) THE NUMBER AND TYPES OF VIOLATIONS DISCOVERED AS THE RESULT OF MULTI-AGENCY COORDINATED INSPECTIONS UNDER THIS SUBTITLE IN THE PREVIOUS QUARTER;
- (3) ANY RECOMMENDATIONS FOR LEGISLATIVE OR ADMINISTRATIVE ENHANCEMENTS TO IMPROVE COMMUNITY QUALITY-OF-LIFE ISSUES AND MULTI-AGENCY COOPERATION;
- (4) A BREAKDOWN OF THE NUMBER OF INSPECTIONS CONDUCTED BY CITY COUNCIL DISTRICT;
- (5) A MAP DISPLAYING THE LOCATION OF THE CITATIONS; AND
- (6) AN AGENCY-LEVEL BREAKDOWN OF:
 - (I) THE AMOUNT OF TIME BETWEEN THE INITIAL COMPLAINT AND THE FIRST INSPECTION;
 - (II) THE TYPES OF CITATIONS ISSUED;
 - (III) THE NUMBER OF REINSPECTIONS CONDUCTED WITHIN THE TIME ALLOTTED; AND

(IV) THE OUTCOME OF INSPECTIONS, INCLUDING:

(A) HOW MANY RESULTED IN A CITATION BEING ISSUED;

(B) HOW MANY VIOLATION NOTICES WERE ISSUED;

(C) HOW MANY VIOLATIONS WERE ABATED WITHIN THE TIME
ALLOTTED; AND

(D) THE NUMBER OF OUTSTANDING CITATIONS AND VIOLATIONS.”

Amendment No. 5

On page 5, strike beginning with “July” on line 1 down through the period in line 2 and substitute “the date that it is enacted. It shall remain effective until a year after the date that it is enacted; and, immediately after that date, with no further action by the Mayor and City Council, this Ordinance will be abrogated and of no further effect.”

The amendments were read and adopted.
