My name is Emily Peterson and I'm from 21202. I regularly run and bike along the proposed site almost daily. I'm also a graduate student who is fairly new to Baltimore, but as a student studying history, I have become acquainted with the historical repercussions of policies like redlining, urban renewal, and poor environmental policies that have disproportionately affected underserved neighborhoods in Baltimore. I really appreciate having greenspace and am concerned about the potential risks to water quality, increased traffic, and increased waste around the area.

I'm concerned that moving the Sisson Sanitation Facility to 2801 Falls Road. I regularly run on this road and have witness issues of trash already along the trail, which poses a risk not only to people walking along the path but also to our waterways as it may blow into the nearby waterway. The Jones Falls is already overburdened by pollution and has a long history of being treated like a waste receptacle. That has started to change in recent years. Placing the sanitation center here would damage the immense progress we've made toward improving water quality in the stream and in the Bay. As someone working the museum field, I am also concerned about how this move may impact the proposed additions to the Baltimore Streetcar Museum, a local gem.

I am writing to voice my opposition to the proposal to move the Sisson Street citizen drop off center to the Potts and Calahan site near the Jones Falls.

As a resident of Mount Washington, and formerly of Bolton Hill, I have used the trails adjacent to the Jones Falls for a decade. I have jogged, cycled, and ridden an electric scooter up and down the trail along Falls Road both recreationally and as a commuter. My husband and daughter routinely ride their bikes down the trail to go to downtown coffee shops together, a treasured tradition for them.

If the site were relocated as planned, the area would be transformed from one of natural beauty and peace to a clamoring waste facility. No amount of careful planning and design would avoid changing the feel of the area from "nature" to "trash dump." It would be tragic for the city to lose the value of this hidden Baltimore gem.

Additionally, it appears that there has been insufficient planning for traffic flow through the area. Closing Falls Road would significantly impact the neighborhood, and there should be a detailed plan for routing users of the new facility, which seems not to have been adequately described.

I strongly encourage you, on behalf of the citizens you represent, to oppose the relocation plan and demand that the city find a more appropriate site with less impact on the recreational spaces we all enjoy.
