Analysis

Current Law

Article 5 – Finance, Property, and Procurement; Section 20-2; Baltimore City Code; (Edition 2000) outlines the process for naming city property.

§ 20-2. Ordinance required for naming.

(a) In general.

City property shall be named or renamed by an ordinance of the Mayor and City Council.

- (b) Referral of bill.
 - (1) When legislation is introduced into the City Council to name or rename City property, the legislation shall be referred to:
 - (i) the Planning Commission;
 - (ii) the municipal agency that has or will have control over the City property;
 - (iii) the Department of Real Estate; and
 - (iv) any other agency that may have an interest in naming the City property.
 - (2) Within 30 days after referral, the Planning Commission and the municipal agency in control of the City property shall submit reports.
 - (3) If the reports are not received within the 30-day time period, the City Council may act on the legislation.

Background

For 32 years, Mary Pat Clarke served as a member of the Baltimore City Council, including 8 years as the councilperson for District 2 and the councilperson for District 14 for 16 years. Clarke had history in 1987 when she was elected as Baltimore's first female council president, which she served for 8 years. Throughout her career, she produced important legislation, including the country's first living wage law in 1994.

Undaunted by the ebb and flow of politics, Clarke remained a constant presence and figure in her community and the City of Baltimore, before, throughout, and after her political career. Mary Pat Clarke is held in high esteem in the City of Baltimore and throughout the city government. If approved, Council Bill 24-0570 would name the playground located at Lake Montebello to the City Council President Mary Pat Clarke Playground in honor of the local politician's trailblazing legacy.

Dear President and City Council Members:

The Law Department has reviewed Mayor and City Council Bill 24-0570 for form and legal sufficiency. The bill would name the playground located at Lake Montebello to be the City Council President Mary Pat Clarke Playground.

The Baltimore City Code allows for the naming of property by ordinance. City Code, Art. 5, § 20-2. There are no requirements for the name of real or personal property as there are for names of streets. Baltimore City Code, Art. 26, §7-1, et. seq. The bill that proposes the ordinance must be referred to the Planning Commission, the municipal agency that will have control over the City property, the Department of Real Estate, and any other agency that has an interest in the property.

The First Reader version of this bill states that it was referred to the City Solicitor, Department of Finance, Planning Commission, Department of Recreation and Parks, Baltimore Development Corporation, Department of Transportation, and Department of Real Estate. Assuming that the land is in control of one of these agencies, then it has been properly referred. As there are no legal impediments to this bill, the Law Department can approve it for form and legal sufficiency.

INTRODUCTION

I am herein reporting on City Council bill 24-0570 introduced by Councilwoman Odette Ramos.

PURPOSE

For the purpose of naming the playground located at Lake Montebello to be named City Council President Mary Pat Clarke Playground.

BRIEF HISTORY

The playground located on DPW property at Lake Montebello was constructed by Baltimore City Recreation & Parks (BCRP) at the request of former Mayor Martin O'Malley. The playground suffered from vandalism and was rendered unusable following damages received during the Freddie Gray uprising. With the receipt of federal ARPA funding, Councilwoman Odette Ramos requested that BCRP use some of those funds to replace this popular community asset.

This legislation requests the formerly unnamed playground be named after former Council President Mary Pat Clarke as "City Council President Mary Pat Clarke Playground." Mary Pat Clarke holds a long and distinguished career as one of our Baltimore's most dedicated public servants. Beyond that distinction, she was the first woman to be elected as City Council President in 1987.

AGENCY/DEPARTMENT POSITION

BCRP has agreed to fabricate the sign for the playground as "Council President Mary Pat Clarke Playground." We request that the legislation be amended to reflect this name. Naming convention does not typically include a recipient's title, but in an effort to highlight the magnitude of her contributions to Baltimore, BCRP has complied with this request. Thought this is ultimately under the purview of DPW, because of our direct involvement with this legislation, we are happy to support the bill.
