**COMMITTEE REPORTS**

**BILL NO. 22-0235 REPORTED FAVORABLY, WITH AMENDMENTS,  
AND ORDERED PRINTED FOR THIRD READING**

Councilmember Costello, for the Ways and Means Committee, reported Bill No. 22-0235 favorably, with amendments.

An Ordinance providing the appropriations estimated to be needed by each agency of the City of Baltimore for operating programs and capital projects during the Fiscal 2023 year.

Committee Amendments to City Council Bill No. 22-0235

**Amendment No. 1**

On page 8, in line 19, before the dollar sign insert a bracket; and, on that same page, in that same line, after "\$2,500,718" insert "[ \$2,304,718".

**Amendment No. 2**

On page 37, in line 4, before the first dollar sign insert a bracket; and, on that same page, in that same line after "\$2,056,900,000" insert "]" **\$2,056,704,000**"; and, on that same page, in that same line, before the third dollar sign insert a bracket; and, on that same page, in that same line after "\$2,147,400,000" insert "]" **\$2,147,204,000**"; and, on that same page, in line 16, before the first dollar sign insert a bracket; and, on that same page, in that same line after "\$3,316,818,946" insert "]" **\$3,316,622,946**"; and, on that same page, in that same line, before the third dollar sign insert a bracket; and, on that same page, in that same line after "\$4,109,379,946" insert "]" **\$4,109,183,946**".

The amendments were read and adopted.

Amendments to City Council Bill No. 22-0235

**Amendment No. 1**

On page 16, in line 34, before the dollar sign insert a bracket; and, on that same page, in that same line, after "10,884,508" insert "]" **\$10,384,508**".

**Amendment No. 2**

On page 16, in line 40, before the dollar sign insert a bracket; and, on that same page, in that same line, after "2,761,775" insert "]" **\$2,261,775**".

The roll was called on the amendment, resulting as follows:

**BILL NO. 22-0236 REPORTED FAVORABLY  
AND ORDERED PRINTED FOR THIRD READING**

Councilmember Costello, for the Ways and Means Committee, reported Bill No. 22-0236 favorably.

An Ordinance providing a tax for the use of the Mayor and City Council of Baltimore for the period July 1, 2022, through June 30, 2023; and setting the semiannual payment service charge for that period.

Favorable report adopted.

The bill was read the second time and ordered printed for third reading.

**BILL NO. 22-0237 REPORTED FAVORABLY  
AND ORDERED PRINTED FOR THIRD READING**

Councilmember Costello, for the Ways and Means Committee, reported Bill No. 22-0237 favorably.

An Ordinance approving the budget estimated to be needed for the Baltimore City Board of School Commissioners for operating programs during Fiscal 2023; providing for certification of the approved budget to the State Superintendent of Schools; and providing for a special effective date.

Favorable report adopted.

The bill was read the second time and ordered printed for third reading.

**THIRD READING TODAY**

Councilmember Costello made a motion, which was duly seconded, to place Bill No. 22-0235 on third reading today.
