
> Re: City Council Bill 14-0425 – Parking Structures – 11 South Eutaw Street, 22 South Gay Street, 101 South Paca Street, and 210 Saint Paul Place

Dear President and City Council Members:

The Law Department has been asked to review City Council Bill 14-0425 for form and legal sufficiency. The bill authorizes authorizing the Mayor and City Council of Baltimore to sell, at either public or private sale, all its interest in certain properties, with parking structures, known as 11 South Eutaw Street (Ward 04, Section 10, Block 0655, Lot 008A), 22 South Gay Street (Ward 04, Section 11, Block 1350, Lot 012), 101 South Paca Street (Ward 04, Section 09, Block 0666, Lot 002), and 210 Saint Paul Place (Ward 04, Section 01, Block 0608, Lot 014). The bill provides for an immediate effective date.

Article II of the Baltimore City Charter gives the Mayor and City Council "full power and authority" to exercise by ordinance certain powers relating to the disposition of parking facilities; specifically, the legislative powers to "sell, lease, convey, transfer or otherwise dispose of any of said land or property regardless of whether or not it has been developed, redeveloped, altered or improved...to any private, public or quasi-public corporation, partnership, association, person or other legal entity." City Charter, Art II, Sec 20(b). Thus, the sale of the parking structures contemplated by Council Bill 14-0425 can proceed under the Article II powers of the City Charter.

The Law Department seeks an amendment to the bill. It is the Mayor and City Council of Baltimore that own the garages. Therefore, it must be the Mayor and City Council that sells the property, although it may use an agent, such as the Parking Authority of Baltimore City, to assist in the sale. The proposed amendment, which is attached to this bill report, clarifies these points.
