Recitals

- 14 The revenue appropriated by this Ordinance represents \$300,000 in excess of the revenue
- relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2023.
- 17 This additional revenue could not have been reasonably anticipated when the Ordinance of 18 Estimates for Fiscal Year 2023 was formulated.
- This appropriation is made necessary by a material change in circumstances since the Ordinance of Estimates for Fiscal Year 2023 was formulated or is for a new program that could
- 21 not have been reasonably anticipated when that Ordinance of Estimates was formulated.
- On November 15, 2023, the Board of Estimates recommended this appropriation to the City
 Council.

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That 1 \$300,000 shall be made available to the MR: Office of Cable and Communications – Service 876 2 (Media Production) as a Supplementary General Fund Operating Appropriation for Fiscal Year 3 2023, to provide funding for balancing the MR: Office of Cable and Communications budget for 4 5 Fiscal Year 2023 due to costs associated with staffing the service. The source of revenue for this 6 appropriation is generated from investment earnings in excess of the amount from this source that was relied on by the Board of Estimates in determining the tax levy required to balance the 7 8 budget for Fiscal Year 2023.

9 SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is 10 enacted.
