A BILL ENTITLED

1 AN ORDINANCE concerning

2 **Supplementary General Fund Operating Appropriation –**  
3 **Mayor’s Office of Employment Development – \$367,000**

4 FOR the purpose of providing a Supplementary General Fund Operating Appropriation in the  
5 amount of \$367,000 to the Mayor’s Office of Employment Development – Program 798  
6 (Youth Works Summer Job Program), to provide funding for additional operating expenses;  
7 and providing for a special effective date.

8 BY authority of  
9 Article VI - Board of Estimates  
10 Section 8(b)(3) and (c)

13 **Recitals**

14 The revenue appropriated by this Ordinance represents funds from the Annual Nonprofit  
15 Contribution in excess of the revenue relied on by the Board of Estimates in determining the tax  
16 levy required to balance the budget for Fiscal Year 2011.

17 This additional revenue could not have been reasonably anticipated when the Ordinance of  
18 Estimates for Fiscal Year 2011 was formulated.

19 This appropriation is made necessary by a material change in circumstances since the  
20 Ordinance of Estimates for Fiscal Year 2011 was formulated or is for a new program that could  
21 not have been reasonably anticipated when that Ordinance of Estimates was formulated.

22 On June 21, 2010, the Board of Estimates recommended this appropriation to the City  
23 Council.

24 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That  
25 \$367,000 shall be made available to the Mayor’s Office of Employment Development – Program  
26 798 (Youth Works Summer Job Program) as a Supplementary General Fund Operating  
27 Appropriation for Fiscal Year 2011, to provide funding for additional operating expenses. The  
28 source of revenue for this appropriation is from the Annual Nonprofit Contribution in excess of

1 the amount from this source that was relied on by the Board of Estimates in determining the tax  
2 levy required to balance the budget for Fiscal Year 2011.
