Council Bill 25-0064, which proposes sweeping changes to residential bulk and yard requirements, may be well-intentioned—but in practice, it threatens to recreate the harmful patterns of exploitation that once devastated Baltimore's Black and working-class communities through blockbusting and predatory real estate practices.
