For the purpose of renewing and continuing the Midtown Community Benefits District and Management Authority; providing for a special effective date; and generally relating to the activities and authority of the Midtown Community Benefits District and Management Authority.

#### **GENERAL AREA**

The Midtown Community Benefits District is generally bound by Interstate-83 on the east, north to Calvert Street, north to 20<sup>th</sup>, west to Howard St, south to North Ave., and west to Tiffany Alley, south to MLK Boulevard, east on MLK to Read Street, south east to Park Avenue, and south to Franklin, east on Franklin to Morton Alley, north to Centre Street then east to Interstate-83

## **HISTORY**

- Ordinance #95-613, approved June 1995, established the Midtown Community Benefits District.
- Resolution #99-019, approved June 1999, renewed the Midtown Community Benefits District.
- Resolution #03-043, approved June 2003, renewed the Midtown Community Benefits District.
- Resolution #04-052, approved June 2004, renewed the Midtown Community Benefits District.
- Resolution #08-001, approved June 12, 2008, was the last renewal of the Midtown Community Benefits District.

### **ANALYSIS**

The Midtown Community Benefits District is an approximately 175-block area, established in 1995 to provide supplemental security services, sanitation and promotional services. Property owners in the district pay a tax surcharge of \$0.132 per \$100 of assessed value. The FY 2013 budget projects that \$1,672,906 in surcharges will be collected. With other contributions and interest, the total income will be \$1,742,506.

The Midtown Community Benefits District Authority has a staff of twenty full-time employees and two part-time employees split among Administrative staff, Clean Team, Green Team, and the Safety Team. The Midtown Community Benefits district Management Authority Board of Directors prepares an operating budget for each fiscal year. The budget is presented to the community at the Spring Town Hall Meeting for comment in March. The Board includes two representatives from each of the four community organizations, one Mayoral representative, one City Council representative, a business representative, two non-profit representatives, and four at-large members.

Some of the Midtown's services over the last year included:

- Vacuum vehicles clean streets five days per week;
- Trash cans are emptied seven days per week;
- 17 acres of green space is served in partnership with the City's Department of Recreation and Parks;
- Off-duty police officers patrol the neighborhoods on Authority-provided Segways 2-3 days per week; and
- Safety cameras are being installed on Charles Street.

The current cycle expires June 2012, hence the need for Resolution #12-0084 which will extend the Authority through June 30, 2016.
