Dear Honorable President Mosby and Members of the City Council:

I am pleased to inform your Honorable Body that I have signed into law this day the following bills:

22-0221 - Zoning - Conditional Use Conversion of Single-Family Dwelling Unit to 2 Dwelling Units in the R-7 Zoning District - Variance - 2315 Eutaw Place

For the purpose of permitting, subject to certain conditions, the conversion of a single-family dwelling unit to 2 dwelling units in the R-7 Zoning District on the property known as 2315 Eutaw Place (Block 3426, Lot 022), as outlined in red on the accompanying plat.

22-0223 - Downtown Management District and Downtown Management Authority

For the purpose of renewing and continuing the Downtown Management District and Downtown Management Authority, subject to certain conditions, for an additional 5 years; generally relating to the activities and authority of the Downtown Management District and Downtown Management Authority; and providing for a special effective date.

22-0228 - Midtown Community Benefits District - Amendment

For the purpose of altering the boundaries of the Midtown Community Benefits District; amending the composition of the District's Board of Directors; revising the enforcement of taxing; adjusting the allowable rate of Supplementary Tax; and generally relating to the Midtown Community Benefits District.

22-0246 - York Corridor Business Improvement District - Establishment

For the purpose of creating a community benefits district, to be known as the York Corridor Business Improvement District; specifying the boundaries of the District; creating an Authority

and providing for its rights, duties, and powers; providing for the selection and composition of the Authority's Board of Directors; providing for an Administrator for the Authority; mandating the financial responsibilities of the Authority and the City in conjunction with the operation of the District; providing for the assessment, collection, and enforcement of a supplemental tax to be collected by and for the Authority; specifying the City's role in maintaining and enhancing existing services; encouraging the creation of partnerships among the Authority, the City, the State, the Federal Government, and property owners not subject to the supplemental tax; designating the Board of Estimates as the agency charged with reviewing and approving various matters relating to the District and the Authority; providing for the renewal, expiration, termination, and approval of the District and the Authority; providing for a special effective date; and generally relating to the existence, operation, and control of the York Corridor Business Improvement District and Authority.

22-0257 - Police Department of Baltimore City - Police Districts - Redistricting

For the purpose of establishing new boundaries of the Baltimore Police Department Police Districts; and providing for a special effective date.

INTRODUCTION AND READ FIRST TIME

Bill No. 22-0300 - By Councilmember Costello

An Ordinance renewing and continuing the Waterfront Management District and Waterfront Management Authority; providing for a special effective date; and generally relating to the activities and authority of the Waterfront Management District and Waterfront Management Authority.

The bill was read the first time and referred to the Economic and Community Development Committee.

Bill No. 22-0301 - By City Council President (Administration - Office of the Comptroller)

An Ordinance authorizing the Mayor and City Council of Baltimore to sell, at either public or private sale, all its interest in certain property that is located at 844 Roundview Road (Block 7622; Lot 002) and is no longer needed for public use; and providing for a special effective date.

The bill was read the first time and referred to the Ways and Means Committee.

A COUNCIL RESOLUTION CONCERNING

Request for State Action – Prohibiting the Use of Address in Creating Car Insurance Premiums

FOR the purpose of calling on the Maryland General Assembly to pass, and the Governor to sign, legislation prohibiting insurance companies from considering location as a factor impacting car insurance premiums.

Recitals

WHEREAS, In Maryland, insurance companies may consider a car insurance customer's zip code or address when evaluating the risk of insuring the potential customer;

WHEREAS, Insurance companies generally consider customers who reside in urban areas as riskier to insure than individuals who reside in rural areas, and as a result Baltimore City residents are likely to have higher premiums than non-City residents;

WHEREAS, Over 60% of Baltimore City residents are Black, and car insurance companies are prohibited from using race as a factor in determining car insurance premiums;

WHEREAS, Analysis performed by ProPublica has found that residents of minority neighborhoods pay higher car insurance premiums than residents of white neighborhoods with the same risk, and the Consumer Federation of America, after reviewing quotes from the 5 largest insurers by zip code, found that major auto insurers charge good drivers who reside in minority neighborhoods 70% more than good drivers who reside in white neighborhoods;

WHEREAS, It is likely that the inclusion of location as a factor in formulating car insurance premiums is a form of redlining that harms minorities, who are already less likely to be able to afford car insurance premiums than whites;

WHEREAS, Some states have implicitly recognized the harm that the inclusion of location as a factor in formulating car insurance premiums causes;

WHEREAS, California prohibits insurance companies from considering zip code or address as a major factor when formulating car insurance premiums, and beginning this year, Michigan will only allow insurers to consider “territories” rather than addresses or zip codes; and

WHEREAS, Our State should take the next step and completely ban the use of location as a factor in formulating car insurance premiums as the inclusion of such information disproportionately harms State residents of color.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, That the City Council calls on Maryland General Assembly to pass, and the Governor to sign, legislation prohibiting insurance companies from considering location as a factor impacting car insurance premiums.

AND BE IT FURTHER RESOLVED, That a copy of this Resolution be sent to the Honorable Chairs and Members of the Baltimore City House and Senate Delegations to the Maryland General Assembly, the Mayor, and the Mayor’s Legislative Liaison to the City Council.
