AN ORDINANCE CONCERNING

1 **Rezoning – Certain Properties in the Charles/North Revitalization Area**

5 District to the B-5-2 Zoning District; as outlined in orange on the accompanying plat, from
6 the B-5-1 Zoning District to the B-5-2 Zoning District; as outlined in purple on the
7 accompanying plat, from the B-2-3 Zoning District to the B-5-2 Zoning District; and as
8 outlined in green on the accompanying plat, from the B-2-3 Zoning District to the O-R-2
9 Zoning District.

1 **SECTION 2. AND BE IT FURTHER ORDAINED,** That as evidence of the authenticity of the
2 accompanying plat and in order to give notice to the agencies that administer the City Zoning
3 Ordinance: (i) when the City Council passes this Ordinance, the President of the City Council
4 shall sign the plat; (ii) when the Mayor approves this Ordinance, the Mayor shall sign the plat;
5 and (iii) the Director of Finance then shall transmit a copy of this Ordinance and the plat to the
6 Board of Municipal and Zoning Appeals, the Planning Commission, the Commissioner of
7 Housing and Community Development, the Supervisor of Assessments for Baltimore City, and
8 the Zoning Administrator.

9 **SECTION 3. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the 30th day
10 after the date it is enacted.
