For many decades, Baltimore Police Department has surpassed its budget and eclipsed all civic funding combined, and I am concerned to see this historic trend continue in the FY21 budget, even in light of recent nationwide uproar about police use of excessive lethal force on communities of color.

Baltimore spends more money per capita on the BPD than the city of Los Angeles spends on LAPD, we have more police officers per capita than many other cities of our size, yet we rank consistently highest in crime somehow. If the peaceful and orderly protests of the past week have demonstrated anything, it is that the community in Baltimore is capable of coming together to create positive change without the intervention or involvement of the Baltimore Police Department.

I respectfully request that you and the other committee members invest rather in long-term societal improvements over further spending on the police department. Increasing the budget for our chronically underresourced school system will do much more to reduce crime than the same amount of money given to BPD. Invest in Youth and Trauma Services. Invest in Homeless Outreach and Affordable Housing. Invest in infrastructure and public transportation. Invest in our communities, not a police force that is not a part of the community it polices.
