1 **AN ORDINANCE** concerning

2 **Supplementary General Fund Operating Appropriation –**
3 **Mayoralty Related – \$60,000,000**

4 FOR the purpose of providing a Supplementary General Fund Operating Appropriation in the
5 amount of \$60,000,000 to the Mayoralty Related – Program 122 (Miscellaneous General
6 Expenses), to provide funding for additional operating expenses; and providing for a special
7 effective date.

13 **Recitals**

14 The revenue appropriated by this Ordinance represents funds from the Fiscal 2009 Fund
15 Balance in excess of the revenue relied on by the Board of Estimates in determining the tax levy
16 required to balance the budget for Fiscal Year 2010.

17 This additional revenue could not have been reasonably anticipated when the Ordinance of
18 Estimates for Fiscal Year 2010 was formulated.

19 This appropriation is made necessary by a material change in circumstances since the
20 Ordinance of Estimates for Fiscal Year 2010 was formulated or is for a new program that could
21 not have been reasonably anticipated when that Ordinance of Estimates was formulated.

22 On June 9, 2010, the Board of Estimates recommended this appropriation to the City
23 Council.

24 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That
25 \$60,000,000 shall be made available to the Mayoralty Related – Program 122 (Miscellaneous
26 General Expenses) as a Supplementary General Fund Operating Appropriation for Fiscal Year
27 2010, to provide funding for additional operating expenses. The source of revenue for this
28 appropriation is from the Fiscal 2009 Fund Balance in excess of the amount from this source that
