16 17	<b>SECTION 1. BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE</b> , That the City Charter is proposed to be amended to read as follows:

20	§ 5. Approval or veto of legislation.
21	(b) Veto; return to Council.
22 23 24	(1) If the Mayor does not approve of an ordinance or resolution passed by the City Council, the Mayor shall return it with written objections to the City Council within three actual regular meetings, not more than one of which shall occur in any one

3 4	(2) [Upon] ON receipt, the Mayor's objections shall be read forthwith to the Council and entered on its Journal. After five calendar days, and within twenty calendar days after
5 6	the ordinance or resolution [shall have been] WAS returned by the Mayor and received by the Council, the Council shall proceed to reconsider and vote upon it.
7 8	(3) If the ordinance or resolution, after reconsideration, [shall be] IS again passed by the City Council by a vote of [three-fourths] TWO-THIRDS of its members, it [shall
9	become] BECOMES an ordinance or resolution of the City. In [such] THESE cases, after
10	the reconsideration, the votes on the question of the passage of the ordinance or
11	resolution over the veto of the Mayor shall be determined by yeas and nays, and the
12	names of the persons voting for and against passage of the ordinance or resolution
13	over the veto of the Mayor shall be entered on the Journal of the City Council.
14	[(d) Items of appropriation.]
15	[If an ordinance or resolution duly passed by the City Council shall embrace different
16	items of appropriation, the Mayor may approve the provisions thereof relating to one or
17	more items of appropriation and disapprove the others, and in such case those the Mayor
18	shall approve shall become effective and those which the Mayor shall not approve shall
19 20	be reconsidered by the City Council, and shall become effective if again passed over the veto of the Mayor by the vote as above prescribed for the passage over the veto of the
21	Mayor of entire ordinances or resolutions. The procedures governing the Mayor's veto of
22	an item of appropriation and the Council's reconsideration of that item shall be the same
23	as those in this section that govern the passage, veto, reconsideration and override of
24	ordinances and resolutions.]
25	SECTION 2. AND BE IT FURTHER RESOLVED, That this proposed amendment to the City
26	Charter be submitted to the legal and qualified voters of Baltimore City, for adoption or rejection,
27	in accordance with Article XI-A, § 5 of the Maryland Constitution, in the form specified by the
28	City Solicitor.
