2 **Taxes – Homestead Credit Percentage**

3 FOR the purpose of modifying the homestead credit percentage for certain taxable years.

9 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That the
10 Laws of Baltimore City read as follows:

12 **Article 28. Taxes**

13 **Subtitle 10. Credits**

14 **§ 10-1. Homestead property.**

15 (A) *IN GENERAL.*

16 Pursuant to the authorization contained in State Tax-Property Article § 9-105, [for the
17 taxable year beginning July 1, 1993,] the homestead credit percentage for the City
18 property tax is [104%] AS PROVIDED IN THIS SECTION.

19 (B) *BASIC RATE.*

20 FOR EACH OF THE TAXABLE YEARS BEGINNING JULY 1, 2011, AND JULY 1, 2012, THE
21 HOMESTEAD CREDIT PERCENTAGE IS 104%.

22 (C) *INCREASED RATE*

23 (1) *TAXABLE YEARS BEGINNING JULY 1, 2013, THROUGH JULY 1, 2019.*

EXPLANATION: CAPITALS indicate matter added to existing law.
[Brackets] indicate matter deleted from existing law.

1 (i) FOR THE TAXABLE YEAR BEGINNING JULY 1, 2013, THE HOMESTEAD CREDIT
2 PERCENTAGE IS 106%.

3 (ii) FOR THE TAXABLE YEAR BEGINNING JULY 1, 2014, THE HOMESTEAD CREDIT
4 PERCENTAGE IS 108%.

5 (iii) FOR EACH OF THE TAXABLE YEARS BEGINNING JULY 1, 2015, THROUGH THE
6 TAXABLE YEAR BEGINNING JULY 1, 2019, THE HOMESTEAD CREDIT PERCENTAGE IS
7 110%.

8 (2) *USE OF PROCEEDS.*

9 ALL REVENUES DERIVED FROM THE INCREASE IN THE CREDIT PERCENTAGE UNDER
10 PARAGRAPH (1) OF THIS SUBSECTION SHALL BE DEPOSITED IN A SPECIAL, NONLAPSING
11 FUND, TO BE USED EXCLUSIVELY TO REDUCE THE CITY PROPERTY TAX.

12 (D) *REVERTED RATE.*

13 FOR THE TAXABLE YEAR BEGINNING JULY 1, 2020, AND FOR EACH SUBSEQUENT TAXABLE
14 YEAR, THE HOMESTEAD CREDIT PERCENTAGE IS 104%.

15 **SECTION 2. AND BE IT FURTHER ORDAINED,** That the catchlines contained in this Ordinance
16 are not law and may not be considered to have been enacted as a part of this or any prior
17 Ordinance.

18 **SECTION 3. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the 30th day
19 after the date it is enacted.
