Major Issues Discussed

- 1. The chairman informed the attendees and public how the hearing would be conducted.
- The Council President gave opening remarks. He talked about the importance of "oversight." He also thanked the public, all the partners, companies and/or attendees for participating during the hearing.
- 3. Six (6) attendees testified. Some highlights from their testimonies were:
 - o Talked about how BGE has changed over the years
 - o Concern about some allegations such as:
 - Workplace violence
 - Race issues
 - The committee was asked to exam how the City is creating contracts, especially surrounding equity
 - o Opposed the conduit agreement
 - o Concern: lacking the use of minority contractors
 - Do not trust BGE
 - o Talked about the importance of transparency and accountability
 - o Thanked the Council for holding the hearing(s)
 - o Transparency lacks when you don't have adequate data!
 - o Comments regarding Exelon
- 4. Four (4) Conduit Users testified. Some highlights from their testimonies were:
 - o The current contract at hand omits pertinent information
 - o There is unclear language in the existing contract
 - o Conduit users met with the Mayor's office staff yesterday
 - Would like to continue work in Baltimore city but may not!
 - o The rights and interests of conduit users must be protected
 - o Conduit costs in city is too excessive
 - o Definitions were given for terminology associated with a "conduit system"
 - Crown Castle provides fiber to businesses, schools and to the community; does not know how the current contract will affect their business
 - o Concern: BGE having sole discretion on projects
 - o Concern: lack of transparency for capital improvements
 - o Concern: having a fair and transparent conduit system
 - o Concerns:
 - Capital improvement commitments
 - Outages caused by conduit workers (who should be held accountable)
 - Costs as a result of relocations

- Future capital improvement projects
- Ensuring all providers are given fair treatment for the use of the conduit system
- o Per the Representative for BGE:
 - This agreement allows for:
 - Opportunity
 - More and better investments
 - Will work more closely with the City of Baltimore
 - BGE is not the "sole" decision-maker
 - BGE goes beyond and over giving contracts to other contractors; and outcomes
 of same have been documented over the years and reported to the PSC.
 - Also discussed: Investments, operations and liabilities
 - The existing contract updates the 2016 agreement
 - BGE denounces racism; it is not tolerated
 - Thinks this deal/contract is strong and a good opportunity for the City
- 5. The Acting City Solicitor talked about processes and/or things that occurred while creating and approving the contract with BGE. She stated, "This is a huge win for the City of Baltimore."
- 6. The committee members stated concerns, made comments and asked questions. Some were:
 - Assessing liabilities
 - Can you talk more about liabilities and/or about who will be accountable for same?
 - Contract with BGE
 - Did the Finance Department and/or an outside consultant assist with the contract?
 - Can Finance explain its role with the contract?
 - How many hours were spent on the contract? Answer: Months were spent completing it
 - Per Finance Department: No outside firms were used for figures and/or numbers given.
 - Is the City still responsible for maintenance? Answer: Yes, but when more improvements are made, maintenance cost will go down.
 - Have BGE talked with the city about purchasing the conduit system recently?
 - Did FMI consultant provide the administration with a figure to purchase the conduit system?
 - Requested by Chairman Costello: Have BGE ever made an offer to purchase conduit system from the City? Is it an asset that BGE wants? Please research and provide findings.
 - Meetings with Conduit Users
 - How many meetings were held with the other conduit users?
 - Did the Finance Department hold any outside meetings?
 - How often will meetings be held with other conduit users?
 - Requested by Councilwoman McCray Would like to know how often meetings will be held with the other conduit users (not BGE), she wants to make sure they have a seat at the table
 - o Conflict of Interest
 - The Acting City Solicitor was asked if she ever worked for Exelon. She replied, yes.
 - Requested by Councilman Stokes: Would like an opinion from the Ethics Board to see if a possible "conflict of interest" exists.

o Quality of Work - is of concern

- Standards associated with the level of work and craftmanship is of concern
- Compliance versus Non-Compliance is of concern
- The contract does not cover all of the expenses that will be needed to maintain the conduit system
- Do you believe BGE can perform a better job than whose who are currently performing the work? I have not heard that our DOT staff is not performing the duties/upkeep that are needed, so why change what is not broken?
- Just because a permit is acceptable does not necessarily mean the work will be performed up to the City's standards!
- Requested by Councilman Schleifer: Provide a list of the names for all Inspectors within the Department of Transportation who will be monitoring the conduit system
- Ouestion: Is BGE seeking to own the conduit system?
- O Consultant Report FMI Consultant
 - We are still waiting on the consultant's report; therefore, we don't know the value of the City's conduit system!
 - Don't know how a decision was made without that report!
 - Evaluations and comparisons should be done by the FMI consultant
 - Is frustrated; is a "rush" deal!
 - FMI have not been able to submit a good evaluation what are we paying them for!

o Concerns:

- Lack of notification pertaining to:
 - Planned work
 - Coordination with the DOT
 - No coordination with all the work that is going on
 - Not given proper notices
 - Is BGE finally going to start giving adequate notifications to residents/community?
 - Would like a letter stating your commitment (BGE) to giving the proper notification regarding things that will happen and/or occur
 - <u>BGE representative responded</u> and talked about coordination, notices and commitment. He also stated, "There is room for improvement and that he hears Councilwoman Ramos "loud and clear."
 - Councilwoman Ramos stated she would like a commitment from BGE, that the company will submit "list of planned projects" in the future
 - Concern: having a floor to value the work excepted by BGE
 - Comment: Seems the City is setting itself up to lose millions of dollars!
 - Getting the best deals for our citizens today as well as in the future!
 - Have a lot of concerns with the contract
 - Issues around competition
 - o Deal is flawed
- o Data Requests and Concerns

- Minutes from monthly meetings
- A specific list of deliverables
- Supplier diversity at the subcontractor's level is of concern
- Requested by Councilwoman Porter: "If both parties would agree with amending the contract; could it be done?" Please provide feedback in writing

Accountability Measures

- Permit and Other Violations
 - Want to make sure when or if there is a disagreement with the City or a breach of contract, it is handled correctly and timely. How do we handle same?

Conduit System

• What is the cost for maintenance? Answer: The operating budget is \$13.6 million

o Revenue received from Other Conduit Users

- Revenue may not be enough!
- Requested by Councilman Conway: Provide the maintenance cost and revenue received from the other users

Questions Addressed to Other Conduit Users

- Have you negotiated a contract?
- Have the City approached you about a contract?
- It is my understanding that the same deal/contract that applies to BGE, applies to you!
- What is the strategy moving forward for the other users?
- Why wasn't negotiation done in advance with the other users? Being pro-active!
- How many of you (other conduit users) are currently in a conduit agreement?
- Concern: Being in limbo (other conduit users) is problematic

Savings

- \$50 million in savings, how did you come up with this figure?
- Would like to see some kind of documentation to verify the \$50 million in savings; to see exactly what the savings are!
- What is the average rate increase to payers?
- How long have BGE and/or the Administration known in would be \$50 million in savings?
- Requested by Chairman Costello: To Mr. Washington, BGE Provide the methodology for how the \$50 million in savings was established/calculated

o Other Topics

- Some discussion regarding "as built" plans
- Clarification regarding "sole discretion"
 - This language permits BGE to do so much!
- Talked about the importance of reaching out to the other conduit users; (having collaborate conversations)

o Contract Approval – Board of Estimates

- On February 15, 2023 the BOE approved the contract
- On March 15, 2023 the Comptroller will placed the contract back on the BOE's agenda how will you vote on it on this date?

- 7. Chairman Costello stated, "the committee received a large package of information from the Administration today; one response was over 495 pages; time wise we have not had time to read the information. We will review the information received and come back to discuss same.
