On March 13, Mayor Young declared a state of emergency in Baltimore City in response to the COVID-19 pandemic. Since then, the City's Emergency Operations Center (EOC) has been activated and is coordinating the City's response to the pandemic. The Department of Finance has assisted the EOC and other City agencies on the procurement of necessary supplies and services to stop the spread of COVID-19 and protect City employees. The expenses are categorized into five categories: 1) core City services; 2) public health response; 3) isolation and quarantine; 4) resident assistance; and 5) small business support. The City has spent between \$36 million and \$38 million since March and expects to spend \$126 million through the first quarter of Fiscal 2021. In addition, the City is projecting large revenue losses, totaling \$68.8 million for Fiscal 2020 and \$103 million for Fiscal 2021. These fiscal impacts are explained in more detail below.

Expenditures

Based on the expenses outlined below, the City estimates spending approximately \$125.6 million through September 2020 on the COVID-19 response.

Core City Services: Expenses in this category include premium pay for public safety and other frontline City employees, which is \$1 million per pay period. The City has also incurred IT expenses, including additional laptops and a remote desktop solution to ensure cybersecurity and necessary bandwidth for teleworking employees. The Baltimore City Fire Department (BCFD) and Police Department (BPD) are spending \$100,000 per week on COVID-19 related overtime.

Health Response: The City is expanding testing and contract tracing for City residents, which are critical components of the City's reopening process and are expected to go on much longer than other City interventions. The City has purchased \$12.5 million of personal protection equipment (PPE) for City employees. The Baltimore City Health Department (BCHD) has also been proactive in purchasing advertisements to promote social distance and combat false information about COVID-19. In addition, BCFD hired private Basic Life Support (BLS) transport units to handle any surge in Emergency Medical Services (EMS) related 911 calls.

Isolation and Quarantine: To support the isolation and quarantine needs of City residents that are positive for COVID-19, awaiting test results, or at high-risk, the City has invested in a variety of options. The Mayor's Office of Homeless Services (MOHS) is renting out four area motels to house individuals experiencing homelessness who are suspected of having COVID-19 or are high-risk and whose primary residence is a City funded homeless shelter. The City has also contracted with a local medical transportation company to provide safe transportation from local shelters and hospitals to the motels. MOHS has contracted with a local staffing company to staff the City funded shelters with security guards, monitors, and caseworkers. In addition, the City outfitted two City-owned buildings as temporary shelters in order to increase social distancing at City funded shelters. Finally, in partnership with the State of Maryland and University of Maryland Medical Systems, the City has rented out the Lord Baltimore Hotel to create an isolation, quarantine, and respite site for residents that test positive or are awaiting results. The City also arranged for rooms at a downtown hotel to house public safety staff that may have been exposed to COVID-19 or are awaiting a test results.

Resident Assistance: The Mayor's Office of Children and Family Success (MOCFS), in partnership with the Department of Planning, the Department Housing and Community Development (DHCD), BCHD, and Finance, has developed a strategy to provide food to City residents in their communities. There are three interventions being funded: 1) food distribution hubs; 2) senior meal delivery; and 3) a grocery supplement. These interventions are expected to support 2.5 million meals, 70,000 food boxes, and up to 12,000 grocery supplements. Additionally, the City gave Baltimore City Public Schools \$3 million to provide laptops to Baltimore students. Further, the Mayor's Office of Immigrant and Multicultural affairs (MIMA)

and DHCD are developing rental assistance programs to be prepared to support residents when the State's moratorium on evictions is lifted this summer.

Small Business Support: The Mayor's Office, in partnership with the Baltimore Development Corporation (BDC), has committed \$5.5 million in small business support. \$500,000 is for small grants to help City businesses pivot their business models in order to produce PPE for City use. \$3.5 million is going to direct cash grants to small businesses, up to \$15,000 per business. Applications close Friday, May 15.

Revenue

The Department of Finance projects a \$68.8 million revenue loss from second quarter projections. This equates to \$20 million a month while social distancing mandates are maintained. These losses are primarily in the areas of tourism (Convention Center sales and Amusement Tax), transportation (Speed/Red-Light Cameras, Parking Tax, Parking Enforcement), and income taxes. These projected losses total \$68.8 million in FY20 and \$103 million in FY21, for a total loss of \$171.8 million over the next fifteen months.

Combined Impact

There is a lot of uncertainty about how long the public health and economic crises sparked by COVID-19 will last and how large the fiscal impact will be. However, based on current information, Finance is projecting that the combined impact of increased expenses and decreased revenue will cost the City a total of \$221.6 million through September 2020.

Other Considerations

Federal Support: Finance is working with the Mayor's Office of Emergency Management (OEM) to track expenses and begin the documentation process for FEMA reimbursement. Finance will be contracting with experts in the various federal funding sources to strategically maximize every dollar of federal support. Baltimore has received \$103 million from the CARES Act, but the law is extremely restrictively and only covers unbudgeted expenses related to COVID-19. Without more flexibility from the federal government, the City will have to backfill lost revenues with the General Fund.

Closeout: In conjunction with the presentation of third quarter projections, Finance will be submitting supplemental appropriations for agencies whose COVID-19 response expenses result in appropriation deficiencies.

Emergency Procurement: On March 17, the Director of Finance issued an emergency authorization in order to aid City agencies in the procurement of needed supplies and services. The emergency procurement process originates at the agency, where they identify their need for potential vendors. The request is routed to the Director of Finance who approves or disapproves the procurement, in accordance with the City Charter – Article VI, Section 11 (e) - Procurement. If approved, the Bureau of Procurement and the Law Department are notified in order to finalize an agreement and create a purchase order. The list of emergency procurements authorized thus far and list of all COVID-19 related purchase orders is attached to this report.

Conclusion

The Department of Finance has reviewed City Council Bill 19-0137R and will attend the hearing for this resolution to answer all questions.
