25-0018 Emergency Scene – Unauthorized Persons Prohibited

FOR the purpose of prohibiting the presence of an unauthorized person within the boundaries of an emergency scene; establishing certain penalties; defining certain terms; and generally relating to unauthorized persons within the boundaries of an emergency scene.

BY repealing and re-ordaining, with amendments, Article 9 - Fire Suppression and Prevention Section 1-2 Baltimore City Code (Edition 2000)

BY adding Article 19 - Police Ordinances Section 25-5 Baltimore City Code (Edition 2000)

BACKGROUND

This bill if enacted would do the following:

- 1. Require that the Fire Chief or their designee identify the emergency scene.
 - a. An emergency scene would be defined as the immediate area necessary for the Fire Department to investigate an emergency.
- 2. Establish a boundary around the scene using any of the following:
 - a. Caution tape
 - b. Poster personal
 - c. Another reasonable method
- 3. Remove the boundaries after the investigation of the emergency

Within the designated emergency scene, unauthorized personnel would not be allowed to loiter. Those who do enter the scene would be warned, and then if they fail to ignore the warning, may be charged with a misdemeanor, fined \$500.00 per offense, sentenced to 90 days imprisonment or both.

The bill also creates a list of excepted personnel, who may be in the boundaries of an emergency scene, including:

- 1. Firefighters
- 2. EMS personnel
- 3. Police personnel
- 4. A victim of the fire
- 5. A family member of a victim
- 6. American Red Cross personnel
- 7. Dept of Housing & Community Development Personnel
- 8. An official (such as the Mayor or Councilmember) as defined by City Code.

All reporting agencies for this bill are supportive or favorable toward it. In particular, the Fire Department has strongly supported it.

FISCAL NOTE

None of the reporting agencies foresee a material impact on them fiscally or administratively.

The Department of Finance, in its report, noted that it expected a high degree of compliance with emergency personnel regarding emergency scenes, and as such, did not anticipate much revenue to be generated from fines. Nor did they anticipate a material difference in expenditure in its enforcement.

BILL SYNOPSIS

This bill mandates that the Fire Chief, or their designated representative, establish an emergency scene during a fire or fire alarm. This designation grants the Chief or Designee the authority to control access to the area, including managing the movement of individuals and overseeing the properties in the vicinity of the fire. The goal is to ensure the safety of all individuals and to facilitate uninterrupted and safe fire operations.

SUMMARY OF POSITION

BCFD strongly supports this legislation. During active fires and other large emergency response events, there are often civilians who linger around the fire or the impacted properties. These individuals are not part of the emergency response effort nor are they there to provide support to the victims. While many of these individuals intent is not harmful, their presence poses significant risks, particularly when they do not follow directives of emergency responders.

Anyone present at the scene of a fire is at risk of injury. Having unnecessary individuals at the scene distracts and impedes critical operations and puts additional lives in danger. Fires are unpredictable, flames, smoke, and toxic gases present immediate hazards; structural collapses, explosions, or sudden changes in wind can cause a fire to escalate or spread rapidly. When first responders arrive, it is essential that they have the space needed to perform their duties and access vital equipment quickly to minimize loss of life and property and to keep themselves safe. Civilians gathering at the scene block fire trucks, obstruct access to emergency equipment, and prevent responders from efficiently addressing the emergency situation. Lastly, victims of fires are often in shock, and the presence of onlookers, offering questions or comments, does not provide the support they need to cope with the trauma they are facing.

This bill will allow BCFD to direct individuals who loiter at the scene of a fire to safer areas, ensuring that they remain at a safe distance and do not interfere with emergency operations. It will also hold individuals accountable for failing to comply with instructions to stay away from the scene, helping maintain a secure environment for both responders and victims. Ultimately, this legislation will enhance safety, improve operational efficiency during emergencies, and better support those affected by these critical events.

FISCAL IMPACT

This bill will not have a fiscal impact on BCFD.

BILL SYNOPSIS

The Baltimore City Police Department has reviewed Council Bill 25-0018 for the purpose of establishing a fire scene; prohibiting the presence of an unauthorized person within the boundaries of an emergency scene; establishing certain penalties; defining certain terms; and generally relating to unauthorized persons within the boundaries of an emergency scene.

SUMMARY OF POSITION

The Baltimore Police Department supports the fire department's establishment of a fire scene and the prohibition of unauthorized persons within the boundaries of that scene. The Baltimore Police Department will fulfill the duties outlined in this legislation if it is enacted.

FISCAL IMPACT

The Baltimore Police Department does not anticipate a fiscal impact if this legislation is enacted.

AMENDMENTS

The Baltimore Police Department has no requested amendments for Council Bill 25-0018 and supports the proposed amendments.

Dear President and City Council Members:

The Law Department has reviewed City Council Bill 25-0018 for form and legal sufficiency. The bill would add a subsection (b) to Section 1-2 of Article 9 of the City Code to allow the Fire Chief or the Chief's designee to identify the boundaries of any emergency scene with caution tape or other reasonable methods when responding to that emergency. It would prohibit anyone but those authorized to be present in that defined emergency scene area. It would also add a prohibition on loitering in an emergency scene area to Subtitle 25 of Article 19 of the City Code.

The City has broad powers to legislate in the interest of public health, safety and welfare and to exercise the common police power. City Charter, Art. II, §§ (27), (47). Since this bill is within that broad authority, the Law Department can approve it for form and legal sufficiency.

BILL SYNOPSIS



The Department of Housing and Community Development (DHCD) has reviewed City Council Bill 25-0018 Emergency Scene – Unauthorized Persons Prohibited for the purpose of prohibiting the presence of an unauthorized person within the boundaries of an emergency scene; establishing certain penalties; defining certain terms; and generally relating to unauthorized persons within the boundaries of an emergency scene.

If enacted, City Council Bill 25-0018 would prohibit unauthorized persons within the boundaries of an emergency scene and establish certain penalties for the repeated disregard of those demarcations. If approved, this Bill will take effect on the 30th day following its enactment.

SUMMARY OF POSITION

DHCD supports this Bill's intent to provide emergency victims a greater degree of protection while those crises are still ongoing. DHCD also appreciates that this Bill specifically lists "personnel from the Baltimore City Department of Housing and Community Development" as among the authorized persons permitted to be present on the scene. This inclusion will ensure that DHCD's Office of the Ombudsman can continue its 24/7 availability to provide critical services and resources to City residents experiencing an emergency that will classify them as homeless. Furthermore, that provision will also ensure that DHCD staff can continue to work along the Fire and Police Departments for emergency building safety inspections and if called for, emergency demolitions.

FISCAL IMPACT

As drafted, this Bill would have minimal fiscal or administrative impact on DHCD.

AMENDMENTS

DHCD does not seek any amendments to this Bill at this time.
