1 AN ORDINANCE concerning

2 **Urban Renewal – Broadway East –**
3 **Amendment _**

4 FOR the purpose of amending the Urban Renewal Plan for Broadway East to reauthorize the
5 acquisition of properties within the Project Area and to correct and clarify certain language;
6 waiving certain content and procedural requirements; making the provisions of this
7 Ordinance severable; providing for the application of this Ordinance in conjunction with
8 certain other ordinances; and providing for a special effective date.

14 **Recitals**

15 The Urban Renewal Plan for Broadway East was originally approved by the Mayor and City
16 Council of Baltimore by Ordinance 88-156 and last amended by Ordinance 02-457.

17 An amendment to the Urban Renewal Plan for Broadway East is necessary to reauthorize the
18 Plan's powers of acquisition and condemnation so that these actions may legally continue, in
19 compliance with § 12-105.1 of the Real Property Article of the Annotated Code of Maryland,
20 and to correct and clarify certain language.

21 Under Article 13, § 2-6 of the Baltimore City Code, no substantial change may be made in
22 any approved renewal plan unless the change is approved in the same manner as that required for
23 the approval of a renewal plan.

24 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That the
25 following changes in the Urban Renewal Plan for Broadway East are approved:

1 (1) In the Plan, amend the first paragraph of C.1. to read as follows:

2 C. Techniques Used to Achieve Plan Objectives

3 1. Acquisition

4 A Property Acquisition Map, which designates those properties to be acquired
5 BY PURCHASE OR BY CONDEMNATION, is attached as Exhibit No. 2.

6 (2) In the Plan, add new C.1.c. to read as follows:

7 C. Techniques Used to Achieve Plan Objectives

8 1. Acquisition

10 C. THE AUTHORITY TO ACQUIRE THE PROPERTIES WITHIN THE PROJECT AREA
11 IS EXPRESSLY CONFIRMED AND REAUTHORIZED THROUGH AND INCLUDING
12 DECEMBER 31, 2014.

13 (3) In the Plan, amend the first paragraph of Appendix A to read as follows:

14 Appendix A

15 Properties for Acquisition and Disposition for Rehabilitation or Redevelopment

16 In addition to those groups of properties to be acquired and disposed of for
17 redevelopment (designated with Disposition Lot numbers on Exhibit 3), the
18 following properties are also being acquired and disposed of for rehabilitation or
19 redevelopment. Certain properties listed below may be used in whole or in part,
20 as rear or side yard space for adjacent property. The acquisition of properties
21 adjacent to or abutting streets and alleys being closed will also include all rights,
22 title, and interest or any private rights of use in and to the adjacent streets, rights-
23 of-way, or alleys AS SHOWN LYING WITHIN THE PERIMETER OF THE LAND
24 DISPOSITION MAP.

25 **SECTION 2. AND BE IT FURTHER ORDAINED,** That the Urban Renewal Plan for Broadway
26 East, as amended by this Ordinance and identified as “Urban Renewal Plan, Broadway East,
27 revised to include Amendment __, dated February 28, 2011”, is approved. The Department of
28 Planning shall file a copy of the amended Urban Renewal Plan with the Department of
29 Legislative Reference as a permanent public record, available for public inspection and
30 information.

31 **SECTION 3. AND BE IT FURTHER ORDAINED,** That if the amended Urban Renewal Plan
32 approved by this Ordinance in any way fails to meet the statutory requirements for the content of
33 a renewal plan or for the procedures for the preparation, adoption, and approval of a renewal
34 plan, those requirements are waived and the amended Urban Renewal Plan approved by this
35 Ordinance is exempted from them.

36 **SECTION 4. AND BE IT FURTHER ORDAINED,** That if any provision of this Ordinance or the
37 application of this Ordinance to any person or circumstance is held invalid for any reason, the

1 invalidity does not affect any other provision or any other application of this Ordinance, and for
2 this purpose the provisions of this Ordinance are declared severable.

3 **SECTION 5. AND BE IT FURTHER ORDAINED,** That if a provision of this Ordinance concerns
4 the same subject as a provision of any zoning, building, electrical, plumbing, health, fire, or
5 safety law or regulation, the applicable provisions shall be construed to give effect to each.
6 However, if the provisions are found to be in irreconcilable conflict, the one that establishes the
7 higher standard for the protection of the public health and safety prevails. If a provision of this
8 Ordinance is found to be in conflict with an existing provision of any other law or regulation that
9 establishes a lower standard for the protection of the public health and safety, the provision of
10 this Ordinance prevails and the other conflicting provision is repealed to the extent of the
11 conflict.

12 **SECTION 6. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it
13 is enacted.
