Appropriations and Expenditures as of FY25 Q3

Notes:

Expenditures and obligations listed in this report are as of March 31, 2025. Agencies may have spent/obligated more since then.

Some appropriations do not have revenue to back them up, which is why some projects have limited or no spending. We are in the process of de-appropriating State and Federal appropriations without revenue to back them up (BOE April 16, will be reflected in Q4 report). We will need to do the same for other revenue categories that do not have revenue to back them up.

Appropriations for projects are split amongst multiple PRJs so there may be spending in one PRJ, but not all of them. We are in the process of consolidating balances for the same project into a single PRJ (BOE April 16, will be reflected in Q4 report).

Agencies may not have spent funds yet because they need more funds to award the project. Starting in FY26, we are trying to fully fund the construction phase in a single fiscal year to the greatest extent possible, but that wasn't the case previously.
