The Department of Planning is in receipt of City Council Bill #16-0647, which would provide a Supplementary State Fund Capital Appropriation in the amount of \$2,000,000 to the Department of Transportation to provide funding for resurfacing neighborhood streets; and provide for a special effective date.

This item has been scheduled for a committee hearing before the Planning Commission will be able to review it and provide a recommendation to the committee. The Department of Planning staff recommends approval of City Council Bill #16-0647.

The Maryland Department of Transportation (MDOT) has awarded a \$2 million grant to DOT for FY 2016. The Fiscal 2016 budget was approved prior to receipt of this grant. Per the grant, these funds must be appropriated in FY16 or the grant will be forfeited, which is why this supplemental appropriation is necessary.

\$1 million will be dedicated to resurfacing asphalt roadways and \$1 million will be dedicated to repairing or replacing concrete roadways.
