AN ORDINANCE CONCERNING

3	FOR the purpose of condemning and closing the subterranean rights under Pleasant Street, 23.35
4	feet east of St. Paul Place and extending Easterly 26.00 feet, as shown on Plat 114-A-54A in
5	the Office of the Department of Public Works; and providing for a special effective date.

14	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the
15	Department of Public Works shall proceed to condemn and close the subterranean rights under
16	Pleasant Street, 23.35 feet east of St. Paul Place and extending Easterly 26.00 feet, and more
17	particularly described as follows:
18	Beginning for Parcel No. 1 at a point on the north side of Pleasant Street, 49.5
19	feet wide, distant North 86° 44' 00" East 23.35 feet, measured along the north
20	side of said Pleasant Street from the east side of St. Paul Place, 54 feet wide, and
21	at a horizontal plane having an elevation of 33.00 feet and descending to an
22	elevation of unlimited depth, and running thence binding on the north side of said
23	Pleasant Street, North 86° 44' 00" East 26.00 feet; thence by a straight line drawn
24	at a right angle to the north side of said Pleasant Street, South 03° 16' 00" East
25	49.50 feet to intersect the south side of said Pleasant Street; thence binding on the
26	south side of said Pleasant Street, South 86° 44' 00" West 26.00 feet, and thence
27	by a straight line drawn at a right angle to the south side of said Pleasant Street,
28	North 03° 16' 00" West 49.50 feet to the place of beginning.

As delineated on Plat 114-A-54A, prepared by the Survey Control Section and filed on October 27, 2008, in the Office of the Department of Public Works.

- **SECTION 2. AND BE IT FURTHER ORDAINED**, That the proceedings for the condemnation and closing of the subterranean rights under Pleasant Street and the rights of all interested parties shall be regulated by and in accordance with all applicable provisions of state and local law and with all applicable rules and regulations adopted by the Director of Public Works and filed with the Department of Legislative Reference.
- **SECTION 3. AND BE IT FURTHER ORDAINED**, That after the closing under this Ordinance, all subsurface structures and appurtenances now owned by the Mayor and City Council of Baltimore continue to be the property of the Mayor and City Council, in fee simple, until their use has been abandoned by the Mayor and City Council. If any person wants to remove, alter, or interfere with them, that person must first obtain permission from the Mayor and City Council and, in the application for this permission, must agree to pay all costs and expenses, of every kind, arising out of the removal, alteration, or interference.
- **SECTION 4. AND BE IT FURTHER ORDAINED**, That no building or structure of any kind (including but not limited to railroad tracks) may be constructed or erected in or on any part of the street closed under this Ordinance until all subsurface structures and appurtenances owned by the Mayor and City Council of Baltimore have been abandoned by the Mayor and City Council or, at the expense of the person seeking to erect the building or structure, have been removed and relaid in accordance with the specifications and under the direction of the Director of Public Works of Baltimore City.
- **SECTION 5. AND BE IT FURTHER ORDAINED**, That after the closing under this Ordinance, all subsurface structures and appurtenances owned by any person other than the Mayor and City Council of Baltimore shall be removed by and at the expense of their owners, promptly upon notice to do so from the Director of Public Works.
- **SECTION 6. AND BE IT FURTHER ORDAINED**, That at all times after the closing under this Ordinance, the Mayor and City Council of Baltimore, acting by or through its authorized representatives, shall have access to the subject property and to all subsurface structures and appurtenances used by the Mayor and City Council, for the purpose of inspecting, maintaining, repairing, altering, relocating, or replacing any of them, without need to obtain permission from or pay compensation to the owner of the property.
- **SECTION 7. AND BE IT FURTHER ORDAINED**, That this Ordinance takes effect on the date it is enacted.
