14	§ 4-1. "Service" defined.				
15	(a) In general.				
16 17	Except as otherwise provided in this section, "service" means the sum of each period of a member's employment with a participating employer.

1	(b) Exclusions.
2 3	Except as provided in subsection (c) of this section, "service" does not include any period of employment:
4 5 6	(1) that has been credited as service under any other City retirement plan for calculating the amount of a retirement benefit or a deferred vested retirement benefit; or
7 8 9	(2) during which the member was not [on the active payroll of] RECEIVING EARNABLE COMPENSATION FOR ANY PORTION OF A PAY PERIOD FROM the participating employer.
10	(c) Exceptions.
11 12 13	The exclusions of subsection (b) of this section do not apply to any period of employment credited to a hybrid member for service as a Class D member of the Employees' Retirement System.
14	(d) Transfers of service.
15 16 17	If a member transfers service to any other City retirement plan, that transferred service may not be counted to determine whether the member is vested in his or her employer contribution sub-account.
18 19	<b>SECTION 2. AND BE IT FURTHER ORDAINED</b> , That this Ordinance takes effect on the date it is enacted.
