AN ORDINANCE CONCERNING

Accident and Disabled-Vehicle Towing

2	FOR the purpose of clarifying and revising the laws governing accident and disabled-vehicle
3	towing to, among other things, further protect the public from unauthorized, predatory
4	towers; conforming these laws to current practices; correcting, clarifying, and conforming
5	related provisions; increasing certain penalties; authorizing the issuance of civil citations,
6	subject to certain penalties, for violations; providing for a special effective date; and
7	generally relating to the towing of vehicles disabled by accident.
