Midtown Community Benefits District & Management Authority– Establishment

Purpose:

FOR the purpose of creating a community benefits district within Baltimore City; specifying the boundaries of the District; creating an Authority and describing its rights, duties, and powers; designating the initial interim Board of the Authority and providing for the selection and approval of a full Board; creating the administrator for the Authority to administer the District; mandating the financial responsibilities of the Authority and the City in conjunction with the operation of the District; providing for a supplemental tax to be collected by and for the Authority; establishing limits and minimums on the amount of the supplemental tax; incorporating the assessment, collection, and enforcement process for the supplemental tax within the procedures and processes already existing; specifying the role of the City in maintaining and enhancing existing services; encouraging the creation of partnerships between and among the Authority, the City, the State, the federal government, and other property owners not subject to the supplemental tax; establishing the Board of Estimates as the entity charged with reviewing and approving various matters relating to the District and the Authority; and otherwise providing for the existence, operation, and control of the District and the Authority.

BACKGROUND

If enacted this bill would create a community benefits district & a management authority empowered to collect a tax and provide services in a designated area (Midtown Community).

<u>City Law</u>

Article 2 of the City Charter empowers the City <u>"To establish, by ordinance, community</u> <u>benefits district management authorities, including the Charles Village Community Benefits</u> <u>District and the Midtown Community Benefits District, within the City to provide services...</u>"

To manage the provision of services provided by the benefits district and the collection of a surcharge or tax to provide for them the City may also create a Management Authority who <u>"promote and market districts, provide supplemental security and maintenance services, provide amenities in public areas, provide park and recreational programs and functions, and after an authority is established, other services and functions as requested by the authority and approved through an ordinance by the Mayor and City Council."</u>

Article 14 (subtitle 7) of the City Code (Special Benefits Districts) describes the previous boundaries, responsibilities, and powers of the district and management authority. This bill would reestablish the district and Management Authority.

The Benefits district will provide the community with several services including (but not limited to):

- Bulk trash removal
- Removing litter from streets, tree pits, bus stops ect..
- Graffiti removal
- Maintain greenspace in the district including park spaces
- Assist with tree planting and maintenance with community associations.
- Provide sustainable green waste removal collection

- Supplemental security provided by safety officers.
- Coordinates homeless outreach
- Educates residents on proper trash and recycling disposal
- Advocates for the District with initiatives, capital projects, city agencies and other opportunities to advance the interest of the district.


The Board of Directors for the Management Authority will serve as the leadership for the district and be comprised of not less than 14 and no more than 25 voting members. An initial interim board of 24 members is appointed in the legislation and includes officer positions for President, Vice-President, Treasurer, & Secretary. The Board should be comprised of at least 2/3s property owners or representatives of properties that pay tax to the District. The Board will be comprised of:

- 1 member appointed by the Mayor
- 1 member appointed by the City Council
- 2 members from each of the following Community Organization in the District:
 - Charles-North Community Association;
 - Bolton Hill Community Association;

- Madison Park Improvement Association, Inc.
- Mt. Vernon-Belvedere Improvement Association
- 4 at large members from each of the following communities:
 - o Charles-North
 - o Bolton Hill
 - o Madison-Park
 - o Mt. Vernon-Belvedere
- Up to 3 members from institutions in the District that make voluntary contributions including:
 - The Maryland Institute College Of Art
 - The University Of Baltimore; And
 - The Peabody Institute Of The Johns Hopkins University
- Up to 6 members representing different constituents in the District which will "enhance the authority's success in furthering the broad objectives of improving and enhancing public services" examples given include major employers, retailers, professionals practicing in the district, & residential tenants.

The Board will be required to submit a yearly financial plan to the Board of Estimates. The plan will consist of a schedule of taxes or charges to be collected and a yearly budget. The financial plan must be adopted after a public hearing held by the Board and then approved by the Board of Estimates

The boundaries of the Midtown Benefits District runs from Tiffany and Tyson Streets to the west, Franklin and Centre Streets to the south, I-83 and Calvert Street to the east, and North Avenue to the north (see map below)



Public Testimony

At the time of this analysis the committee has received letters from community members & institutions offering testimony. Many of these letters have offered their support to the proposed establishment of the District. They have noted that the services and resources offered previously have been a benefit to the community. Several of these letters consistently note that they are not satisfied with the services offered by the district – particularly in the area of trash pickup and other cleaning services. In these letters several community members note that problematic properties flaunt the correct way to dispose of trash in the community and indicate that it has lead to issues with pest.

A number of comments received by the committee suggest that tax money collected by the Management Authority be placed into an escrow account until these issues are fixed (see letters in Public Testimony section of hearing packet or in the bill file).



I am writing to express my concern regarding the direction of the Midtown Community Benefits District over the past few years. During this time there has been a significant reduction in Midtown's services, specifically those centered around its core mission of keeping the community "clean, green, and safe". This has been particularly disappointing because our additional tax dollars are for this purpose.

The central goals of "clean, green, and safe" were amplified in the Midtown Community Plan from around 2000—a straightforward document that put forward how the appearance of our



community (often looking dirty, run down, and trash laden), was holding us back from our potential—and that activities that cleaned and greened the public realm would improve this community. With so many people, visitors, and traffic, a great deal of trash is generated here. Properties that have been "problems" have for decades been skirting the City's trash requirements—many since Midtown was authorized in the late 1990s. Midtown has done little in the way of reigning these landlords in and all the work has been left to the residents of the community.

We need Midtown to stay focused on their core mission of clean, green, and safe. If they can accomplish those goals, then discussions can be had regarding other initiatives—but until this benchmark is met—it should be their 100% priority. I ask that you consider these facts as you renew Midtown's contract. Perhaps you can tell them in no uncertain terms that they need to focus on their core mission, or ask for new leadership, or enable us to put our Midtown tax in an escrow account until we see evidence of their refocus.



I am a longtime resident of Mt. Vernon and have questions about the Midtown Community Benefits District's performance. Its core mission is to keep our communities Clean and Safe, yet trash is a major issue and I cannot remember the last time I saw a safety patrol. I avoid being alone outside after dark. I have reviewed MIdtown's nice website, but would feel better if there was reinforcement in its efforts so that the community felt safer and looked cleaner. As the Council considers the renewal of Midtown's contract, we ask that you directly communicate to Midtown staff your expectations about its core mission and performance. Perhaps there should be sanctions in place until they can demonstrate a renewed commitment to Clean (though I want to thank Curtis who has been helpful dealing with chronic trash and dumping on Brexton Street when I contact him and send a photo) and Safe (its Green mission appears to be doing well) in Mt. Vernon and our other communities.

I have been a resident of Mt Vernon and have for the past thirteen years and paid the Midtown Benefits Tax. Throughout this period the services that Midtown should provide as part of its mission to make the district "clean, green and safe" have deteriorated to such an extent that we, as residents, need your help to refocus the organization.

Midtown used to employ street cleaners who were conscientious, friendly, and efficient. We knew them personally, they were part of the community, and kept our streets clean. This task has since been outsourced and the sorry state of our streets shows the results. Midtown is also lax at forcing serial trash offenders to comply with city standards.

Midtown used to be active in planting and maintaining trees - this has deteriorated in the past few years as well.


Safety is not a major issue in this neighborhood but this is due to the overall reduction in crime in our city. This is something to cherish and be proud of. Midtown has done nothing on this front.



During this time there has been a significant reduction in Midtown's services, specifically those centered around its core mission of keeping the community "clean, green, and safe". Dear Council President Cohen:

I am writing to express my concern regarding the decline in the quality of service of the Midtown Community Benefits District over the past few years. They are not meeting their core mission objectives of keeping the community "clean, green, and safe". They have subbed their key services to a third-party provider and there seems to be little oversight. The further you get from Charles Street the more likely you are to find the same trash littering the streets for days and weeks at a time. This should not happen anywhere in the city, but considering we all pay an additional tax, it is particularly unacceptable in Midtown.

The central goals of "clean, green, and safe" were amplified in the Midtown Community Plan from around 2000—a straightforward document that put forward how the appearance of our community (often looking dirty, run down, and trash laden), was holding us back from our potential—and that activities that cleaned and greened the public realm would improve this community. With so many people, visitors, and traffic, a great deal of trash is generated here. There are many "problem" properties that have been skirting the City's trash requirements for decades—many since Midtown was authorized in the late 1990s. Midtown has done little in the way of reigning these absentee landlords in or at least proactively planning to pick up the piles of trash they strew around the neighborhood, and all the work has been left to the residents of the community. Midtown is missing in action and failing to meet its most basic responsibilities.


Furthermore, we are facing new threats that need to be addressed, such as the massive crow infestation in Mount Vernon. While no expects Midtown to rid Mount Vernon of crows, they could show initiative and deal with the hygiene issues related to guano[1] hotspots. They should have clean-up crews with the proper protective clothing cleaning sidewalks and common areas in Midtown. Midtown has failed to meet their basic obligations and seem not understood how their mission has evolved to meet new threat to public hygiene.

We need Midtown to stay focused on their core mission of clean, green, and safe. If they can accomplish those goals, then discussions can be had regarding other initiatives—but until this benchmark is met—it should be their 100% priority. I ask that you consider these facts as you renew Midtown's contract. I am asking you to tell them in no uncertain terms that they need to focus on their core mission, or, if they are unable or unwilling to do so, to ask for new leadership, or least enable us to put our Midtown tax in an escrow account until we see evidence of their refocus. Dear City Council President Cohen and City Council Members,

I write to request that you take action to ensure a course correction for the Midtown Community Benefits District. A few years ago, my husband and I returned to my home state of Maryland after a decade in New England and, after many years of suburban living, we were thrilled to return to city living. We chose Mt. Vernon, where we purchased and restored a rather dilapidated historic townhouse on Park Avenue. We invested substantially in this property and were excited to become part of this community. Part of the draw for us was that we had been assured that the Midtown Community Benefits District ("MCBD" or "the District") was actively engaged in keeping Midtown "clean, green, and safe," and since our arrival we have contributed significant tax dollars that are intended to support this mission. We are disappointed and disgusted to find that the MCBD is failing spectacularly to accomplish its mission. Midtown is covered in trash, dog waste and graffiti. This architecturally beautiful and fascinating part of the city is being allowed to become a pigsty. I am told, in fact, that some of these properties and landlords have been problematic for *decades*; certainly this blatant disregard for city laws and regulations has been an ongoing problem since we purchased our property three years ago. There are so many things we love about Baltimore and, specifically, about our neighborhood, but the deteriorating living environment is frankly depressing.

I recognize that some members of the Council may feel that Baltimore has bigger and more urgent problems than the decay of Midtown. However, Baltimore cannot build the wealth we require to address the stubborn and difficult problems that are statistically associated with poverty if our middle class neighborhoods are unattractive places to own homes.

For these reasons, I join my neighbors in urging you to ensure that the MCBD refocuses on its core mission of clean, green, and safe. This needs to be addressed as an "all hands on deck" situation at the District. At a minimum, it is essential that other projects and programs be paused until the District

has accomplished these objectives: (1) eliminating un-binned trash and dog poop from our streets and alleys and taking enforcement action against violators and (2) remediating graffiti as soon as it appears and taking action to deter further vandalism. To the degree that the contract with the MCBD provides the Council with inadequate leverage to ensure that District shows meaningful progress on its fundamental responsibilities, it is essential that such provisions be inserted when the Contract is renewed. I'm aware that neighbors have suggested that you take action to replace the MCBD's senior leadership and or escrow tax proceeds until there is evidence of their refocus. These seem to me to be sound suggestions, but I believe the Council likely also has additional tools at its disposal as well and I urge you to use your collective creativity and skills to solve this problem.

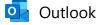

Those of us who have lived in Mount Vernon for some time have dealt with various changes over the years at Midtown, but our understanding has always been that their core mission was to make Mount Vernon, and the other communities, "clean, green, and safe." These goals were amplified in the Midtown Community Plan which was developed in 2000 after two years of consultation and input from all 4 neighborhoods- Mt. Vernon, Bolton Hill, Madison Park, and Charles North —a straightforward document that put forward how the appearance of our community (often looking dirty, run down, and trash laden), was holding us back from our potential—and that activities that cleaned and greened the public realm would improve this community.

You may be surprised to learn that Mount Vernon's median income is \$38,000, much lower than the city-wide's median income of \$50,000. These large, former mansions are largely chopped up into numerous apartments—many people live here—perhaps the largest population of the Midtown communities. With so many people, visitors, and traffic, a great deal of trash is generated here. Properties that have been "problems" have for decades been skirting the City's trash requirements—many since Midtown was authorized in the late 1990s. We need Midtown to stay focused on their core mission of clean, green, and safe. If they can accomplish those goals, then perhaps other discussions can be had regarding other initiatives—but until this benchmark is met—it should be their 100% priority. On behalf of the Mount Vernon-Belvedere Association (MVBA), we are writing to share the association's support for the City of Baltimore Council Bill 95-613 for the purpose of renewing the Midtown Community Benefits District (MCBD) and the Midtown Community Benefits Management Authority. Our support for the authorization of MCBD is predicated on a few conditions to be noted in the public record outlined in our testimony before the Housing and Economic Development Committee hearing scheduled for Tuesday, February 18, 2025. These conditions are below:

- 1. MCBD must prioritize its core mission—clean, green, and safe enhanced services that are underwritten by the surcharge tax and that may require tightened legislation to ensure they are central to Midtown's mission;
- 2. MCBD's conduct an evaluation of its Block-by-Block contract to determine effectiveness; and,
- 3. MCBD leadership and its Board of Directors are responsive to the concerns of its constituent communities, as expressed in condition 1 above.

Over the last two years, we have heard from many constituents that MCBD has migrated from its core mission, underwritten by the surcharge, to provide high-quality enhanced services. The core, clean, green, and safe functions were identified through a thoughtful grass roots planning process that led up to the creation of MCBD in 1996. These enhanced services are as relevant today as they were in 1996—clean, green, and safe public spaces are central to fostering healthy and vibrant communities.


In 2000, MCBD published a Midtown Community Plan that was authored by Charlie Duff, with extensive input and participation from the four communities of Midtown. 

I am writing to express my concern about the Midtown Community Benefits District. I believe that the core mission of Midtown is to keep the area "clean, green, and safe," and those of us who live here pay an additional tax specifically to fund this mission.

The Midtown Community Plan from around 2000 documented that the appearance of our community - often dirty and trash laden - was holding us back. The Plan stated that activities that cleaned and greened the public realm would improve the community. Our neighborhood generates trash, because we are relatively densely settled, and because we have visitors to neighborhood restaurants and other businesses. Most neighbors do a good job keeping trash in

bins that are put out on the correct day of the week. Many visitors do a decent job of disposing of garbage correctly – although a few more public trash cans would be welcome. However, there are exceptions.


There are several problem properties well known to the neighborhood. I imagine these properties are well known to the City as well. These "problems" have been flouting the City's trash requirements for decades - many since Midtown was authorized in the late 1990s. Midtown has done little to correct these repeat offenders, leaving the work to the residents of the community. This is galling, as we are paying Midtown to address the situations that make the neighborhood unsightly and dangerously rat-infested.

We need Midtown to stay focused on their core mission of clean, green, and safe. I ask that you consider the central concern of garbage as you renew Midtown's contract. Perhaps you can tell them to focus on their core mission, or ask for new leadership, or enable us to put our Midtown tax in an escrow account until we see evidence of their refocus.






