Major Issues Discussed

- 1. Chairman Conway called the hearing to order, read the bill for LO21-0015 & LO23-0041, and introduced the committee members in attendance.
- 2. Chief Wallace and Command Staff began a presentation on Fire Department operations (presentation in the file) and responded to committee member questions. Topics included:
 - a. Fire deaths year to year
 - i. 8 in 2022 16 in 2023
 - b. Arson in vacant buildings
 - i. This is happening but goes down once the building is labeled code x^1 and boarded up.
 - c. Proactively ID homes without power for support to prevent fire deaths in the winter.
 - d. Current status of the fleet:
 - i. Supply is very limited not only vehicles but parts as well.
 - ii. DGS is down 30 mechanics.
 - iii. Looking to stock parts to help alleviate wait times.
 - e. How long does it take 911 dispatch to pick up a call:
 - i. The goal is 15 seconds but Baltimore is not currently in compliance with this and has not been for much of the summer.
 - ii. Dispatch staffing is very low and the system is over-utilized.
 - 1. Calls that could be going to other resources like 988 are first going to 911.
 - iii. Life over property is the guiding principle of dispatch triage.
 - f. What is the center like how are calls triaged and elevated to departments?
 - i. There are no barriers in the call center and several agencies are on the floor.
 - ii. A BPD sergeant and supervisor are always on the floor.
 - g. Nearly of BCFD injuries are at vacant properties what do those injuries consist of?
 - i. Most are minor injuries fall into 5 categories:
 - 1. Overexertion (most common)
 - 2. Burns
 - 3. Needle Sticks
 - 4. Lacerations and contusions
 - 5. Exposures
 - h. Workday Pay issues
 - i. There are still workday issues but pay issues are being resolved.
 - ii. Other issues include changes in staffing such as promotions or other changes.
 - i. Stricker Street Report Recommendations
 - i. BCFD is creating a priority list and subcommittees for the implementation of recommendations.
 - j. % of Apparatus out of service
 - i. Currently one truck is offline it is being repaired and should resume service shortly.
 - k. Attrition rates for BCFD
 - i. Hard to estimate currently the BCFD is running one fire academy and planning for another to help fill vacancies.

¹ Code X is a designation that a structure is not safe to fight a fire in internally.

- ii. There are rumors of a "mass exodus" due to the number of members reaching retirement.
- iii. Recruiting efforts especially with EMS are hampered by other municipalities offering better pay in less utilized departments.
- 3. Chairman Conway recessed the hearing.
