For the purpose of establishing a new, uniform tax rate for parking a motor vehicle on a parking lot or in a garage; providing for a special effective date; and generally relating to the imposing and administration of the parking tax.
By repealing and reordaining, with amendments Article 28 - Taxes Section(s) 22-3 Baltimore City Code (Edition 2000)
SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the Laws of Baltimore City read as follows:
Baltimore City Code
Article 28. Taxes
Subtitle 22. Parking Tax
§ 22-3. Rate of tax.
[(a) Effective July 1, 2002.
(1) In general.
For the period July 1, 2002, through June 30, 2003, the rate of the tax is as stated in this subsection.
(2) Hourly, daily, or weekly.
For parking on an hourly, daily, or weekly basis, the tax is 11% of the fee or other consideration received, directly or indirectly, for or in connection with that parking.
