Amendment No. 1

On page 4, after line 18, insert:

"(3) BEGINNING IN FISCAL YEAR 2022 AND CONTINUING EVERY 3 YEARS THEREAFTER,

THE FISCAL AGENT SHALL CONDUCT A COMMUNITY-WIDE NEEDS ASSESSMENT TO

ASSIST THE BOARD IN DETERMINING GRANT-MAKING AREAS."

Amendment No. 2

On page 5, at the beginning of line 19, insert "(I)"; and, on that same page, strike lines 20, 23, and 24 in their entireties; and, on that same page, in line 22, after the semi-colon, insert "AND"; and, on that same page, in lines 21 and 25, strike "(II)" and "(IV)", respectively, and substitute "(A)" and "(B)", respectively; and, on that same page, after line 26, insert:

- "(II) OF THE NON-VOTING MEMBERS OF THE BOARD:
 - (A) 1 SHALL BE THE CITY SOLICITOR OR THE CITY SOLICITOR'S DESIGNEE; AND
 - (B) 1 SHALL BE THE DIRECTOR OF FINANCE OR THE DIRECTOR'S DESIGNEE.";

and, on that same page, after line 27, insert "(I) IN GENERAL."; and, on that same page, after line 28, insert:

- "(II) YOUTH PARTICIPATION.
 - (A) IN THIS SUBPARAGRAPH, "YOUTH" MEANS AN INDIVIDUAL BETWEEN THE AGES OF 14 AND 25, INCLUSIVE.
 - (B) EXCEPT AS PROVIDED IN SUBSUBPARAGRAPH (C), AT LEAST ONE-THIRD OF THE BOARD SHALL CONSIST OF YOUTH MEMBERS.
 - (C) THE BOARD OF ESTIMATES MAY WAIVE THE REQUIREMENT IN SUBSUBPARAGRAPH
 (B) IF BOARD OF ESTIMATES FINDS THAT THE FUND'S BOARD TAKEN REASONABLE

AND DILIGENT EFFORTS TO COMPLY WITH THAT REQUIREMENT AND THAT THOSE EFFORTS HAVE FAILED.".

Amendment No. 3

On page 1, in line 25, after "9-8", insert ", 9-10"; and, on page 7, in line 20, after the comma, insert "A RELEVANT COMMITTEE OF"; and, on page 8, after line 11, insert:

"§ 9-10. ANNUAL REPORT.

NO LATER THAN JUNE 30 OF EACH YEAR, THE BOARD SHALL PREPARE AND SUBMIT A REPORT TO THE MAYOR AND CITY COUNCIL DETAILING THE ACTIVITIES AND THE IMPACT OF THE FUND.".
